MINUTES SEPTEMBER 12, 2019 REGULAR TOWN COUNCIL MEETING 6:00 P.M.

Present: Jane S. Darby, Mayor, Susan Hornsby, Jerome Kizer and Patti Smyer, Council Members; Absent: Crawford Moore, Mayor Pro Tempore. *Quorum of Council Present*.

Pledge and Invocation

Councilman Kizer led those present in the Pledge of Allegiance and an invocation.

Approval of Minutes

- **A.** Regular Meeting Minutes, August 8, 2019 Councilwoman Smyer moved to approve the minutes of the regular Council meeting held August 8, 2019, seconded by Councilwoman Hornsby and approved 4 0.
- **B.** Emergency Council Meeting Minutes, September 2, 2019 Councilman Kizer moved to approve the minutes of the emergency Council meeting held on September 2, 2019, seconded by Councilwoman Hornsby and approved 4 -0.

Proclamations and Presentations

- **A.** Starfish Awards Mayor Darby recognized Tommy Sandel and Jay Watts and thanked them for their help in planting sea oats on the dunes. Councilman Kizer was presented with a Starfish Award with thanks for purchasing the turtle-friendly lighting at Coots.
- **B.** Representatives from Republic Collection Issues Rob Carter, Ivan Figeroa and Scott Greiter of Republic Services were present. Mr. Carter addressed Council and those in attendance and apologized for sub-par performance on July 4th. Mr. Carter said that Republic had issues with maintenance and turn over at the time but was back on track and working hard to improve services. Mr. Carter stated, "Probably the biggest issue is we weren't prepared for summer this year." Mayor Darby told Mr. Carter she was looking forward to the continued improvement.
- C. Edisto Beach Annual Beach and Inshore Survey 2018 Monitoring Report and Preliminary Damage Report Steven Traynum and Dr. Patrick Barrineau of Coastal Science and Engineering were present for the meeting. Mr. Traynum gave a PowerPoint presentation, the slides of which are attached to these minutes. Mr. Traynum told Council and those in attendance that a post Hurricane Dorian survey had been completed and Edisto Beach lost approximately 30,000 cubic yards of sand during Dorian, which is not a significant loss. If the Town were to put the sand back in the area where it was lost, the easiest way to accomplish that would be to have the sand brought in from inland. That would cost approximately \$20/yard for a total of \$600,000. Another option would be to transfer sand from the accretional bulge past the point on the south end. This would cost about half as much, as long as the trucks could utilize the beach and not have move on and off at beach accesses. If FEMA approved that scope of work, they would cover 75% of the cost.

The 2018 monitoring report specifically focused on erosion rates from volumes surveyed October 2018 to those surveyed in April 2017. Edisto Beach lost approximately 149,500 cubic yards. Overall, 77% of the nourishment volume placed in 2017 is still present within the project boundaries.

New Business

- A. First Reading of Ordinance No. 2019-15 to Amend Section 2-142 of the Town's Code of Ordinances, Town Administrator Duties Councilwoman Smyer moved to approve the first reading of Ordinance No. 2019-15 to Amend Section 2-142 of the Town's Code of Ordinances to remove "publish a newsletter" from the duties of the Town Administrator. Councilman Kizer seconded the motion, which was approved 4-0.
- **B.** First Reading of Ordinance No. 2019-18 to Amend Section 86-33 (4) (b)(3) to Replace "Newsletter" with "Website" Councilman Kizer moved to approve the first reading of Ordinance No. 2019-18 to Amend Section 86-33(4)(b)(3) to replace "newsletter" with "website" since the newsletter is no longer published. The motion was seconded by Councilwoman Smyer seconded the motion which was approved 4-0.
- C. Special Event Application, Edisto Watersports & Tackle, Edisto Watersports Redfish Tournament Councilman Kizer moved to approve the special event application submitted by Edisto Watersports and Tackle to hold a Redfish Tournament on October 19, 2019 from 7:00 a.m. 5:00 p.m. Councilwoman Hornsby seconded the motion, which was approved 4-0.
- **D. Recurring Special Event Form, Edisto Chamber of Commerce, 2019 Fall Festival** Councilwoman Smyer moved to approve the recurring special event form from the Edisto Chamber to hold the 2019 Fall Festival on October 19, 2019 from 11:00 a.m. -4:00 p.m. in front of Palmetto Plaza. The Chamber is requesting 4-6 trash receptacles along with traffic barriers for road closures on Jungle Road in front of Palmetto Plaza and to block Jungle Road at Highway 174 from 7:00 a.m. until the festival starts to allow for safe vendor set up. Councilman Kizer seconded the motion, which was approved 4-0.
- E. Award of RFP No. 2019-04 Edisto Beach Civic Center Stainless Steel Cable Repair/Replace Councilwoman Hornsby moved to approve the award of RFP No. 2019-04 to Structure Tec at a cost of \$12,256 to be funded from 45-7500.9040 Civic Center Building Maintenance and authorize the Town Administrator to execute said contract. Councilman Kizer seconded the motion, which was approved 4 0.
- **F.** Award of No. RFP 2019-05 Asphalt Yacht Club Road Councilwoman Smyer moved to approve the award of RFP No. 2019-05 to Action Services, Inc at a cost of \$36,937 to be funded from the Hospitality Fund and authorize the Town Administrator to execute said agreement. Councilman Kizer seconded the motion which was approved 4-0.
- G. Recreational Master Plan Funding \$11,875 Councilman Kizer moved to provide matching funds for the South Carolina Parks, Recreation and Tourism grant in the amount of \$11,875 to be funded from the Hospitality Fund. Councilwoman Smyer seconded the motion which was approved 4-0.
- H. First Reading of Ordinance No. 2019-16 to Amend and Completely Restate Division 2 of Article IV of Chapter 2 Entitled "Purchasing" of the Town's Code of Ordinances Councilman Kizer moved to approve the first reading of Ordinance No. 2019-16 to amend and completely restate Division 2 of Article IV of Chapter 2 entitled "purchasing" of the Town's Code of Ordinances. This amendment revises the

current code to include changes in state purchasing codes. Councilwoman Hornsby seconded the motion which was approved 4-0.

- I. First Reading of Ordinance No. 2019-17 to Amend Article IV of Chapter 2 of the Town's Code of Ordinances to Enact Division 3 Entitled "Ethics in Public Contracting" Councilwoman Smyer moved to approve the first reading of Ordinance No. 2019-17 to amend Article IV of Chapter 2 of the Town's Code of Ordinances to enact Division 3 entitled "Ethics in Public Contracting." The motion was seconded by Councilman Kizer and approved 4-0.
- **J.** Water Improvement Project Dominion Energy Power to wells and Plant \$11,739 Councilman Kizer moved to approve the installation of electric by Dominion Energy for the Water Improvement Facility in the amount of \$11,739 to be funded from Water R & R. Councilwoman Hornsby seconded the motion which was approved 4-0.
- **K.** Convenience Station Rehabilitation \$25,000 Councilwoman Smyer moved to approve the rehabilitation of the convenience station. The estimated cost of the work is \$25,000. The ramps will be removed (\$3,200), the containers will be placed to make the flow of traffic more efficient. The entire site will be regraded and stabilized (\$10,000). New signs will be installed in both English and Spanish (\$336). Trees will be removed in the front of the site so it can be used for a laydown yard (\$5,500). The fence will be repaired. The \$25,000 will be transferred from continency (10-4900.9999) to Capital Improvements (10-4110-6500). Councilwoman Hornsby seconded the motion. Mayor Darby asked Administrator Hill to check and see if the recyclables from the convenience station were going to the same place as the rest of the garbage taken from there. The Mayor called for the vote and the motion was approved 4-0.
- **L. Emergency Work \$21,000** Councilwoman Smyer moved to approve Amendment #2 with CSE Post Storm (Hurricane Dorian) Beach Monitoring Survey in the amount of \$15,000 and the rental of trash pumps and hoses from Sunbelt for \$5,881. Councilman Kizer seconded the motion, which was approved 4-0.
- **M.** Ocean Ridge Storm Debris Councilman Kizer moved to defer the decision on removal of the Ocean Ridge storm debris until further information is obtained. Since Ocean Ridge is a private subdivision, costs incurred by the Town picking up storm debris are not reimbursable through FEMA. After Hurricane Matthew the cost of storm debris removal was \$105,163. The Town portion was \$21,032. FEMA paid the \$84,131 because the debris removal was pre-approved and debris removal was a health and safety issue. The motion was seconded by Councilwoman Hornsby and approved 4 0

- A. Municipal Elections Commission There is still a vacancy on the Municipal Elections Commission.
- **B.** Water and Sewer Committee The term of Bob Renner expires on September 15th, 2019. Councilwoman Smyer moved to approve the advertising of the vacancy, seconded by Councilman Kizer and approved 4-0.

Edisto Beach 2018-2019 Monitoring & Post-Dorian








Edisto Beach Sand Volume

Jun 2018 – July 2019 lost 132k


2019 holds ~909,000 cy more sand than 2005 pre-project




Project area has lost 322k since April 2017



Volumes by Reach




Volumes by Reach




Volumes by Groin Cell
