Pledge and Invocation

Councilwoman Hornsby led those in attendance in the Pledge of Allegiance and an invocation.

Approval of Minutes

- **A.** Special Called Meeting Minutes, October 8, 2019 Councilman Kizer moved to approve the minutes of the special Council meeting of October 8, 2019 seconded by Mayor Pro Tem Moore and approved unanimously.
- **B.** Public Hearing Meeting Minutes, October 10, 2019 Councilwoman Smyer moved to approve the Public Hearing minutes from the October 10, 2019 meeting, seconded by Councilwoman Hornsby and unanimously approved.
- C. Regular Council Meeting Minutes, October 10, 2019 Mayor Pro Tem Moore moved to approve the minutes of the regular Council meeting of October 10, 2019, seconded by Councilman Kizer and approved unanimously.

Proclamations and Presentations

A. Five Year Service Award – Ken Dasen – At the Council worksession, Mayor Darby presented Assistant Police Chief Ken Dasen with a five-year service pin and certificate with many thanks.

Old Business

A. Second Reading of Ordinance No. 2019-25 to Amend Section 66-78 (a) of the Town's Code of Ordinances – Councilwoman Smyer moved to approve the second reading of Ordinance No. 2019-25 to Amend Section 66-78 (a) of the Town's Code of Ordinances dealing with the length of twice-weekly garbage pickup. Councilwoman Hornsby seconded the motion which was unanimously approved.

New Business

- **A.** Oath Of Office Municipal Judge Tom Weeks gave the Oath of Office to the newly-elected Mayor Jane Darby and the newly-elected Councilmembers Jerome Kizer and Crawford Moore.
- **B.** Election of Mayor Pro Tempore According to the Town's code, a Mayor Pro Tempore must be elected after each general election. Crawford Moore was elected by unanimous ballot to serve as Mayor Pro Tempore for Council.

- **C.** Annual Financial Report Fiscal Year Ending June 30, 2019 Eve McCoy, CPA, gave her report for the fiscal year ending June 30, 2019 and was a clean report. The 2019-2020 audit report is posted online at www.townofedistobeach.com/finance-reports.
- **D. 2020 Meetings and Holidays Schedule** Councilman Kizer moved to approve the 2020 meetings and holidays schedule, seconded by Councilwoman Smyer and approved unanimously.
- **E. 2020 Council Goal Setting Retreat** Councilwoman Smyer moved to approve holding the 2020 Council Goal Setting Retreat on February 26 starting at 9:00 a.m. in Council Chambers. Councilwoman Hornsby seconded the motion, which was approved unanimously.
- **F.** Resolution No. 2019-R28 to Revise the Freedom of Information act Policy and Request Form Councilwoman Hornsby moved to approve Resolution No. 2019-R28 to revise the Freedom of Information Act Policy and Request Form. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.
- **G. Jungle Shores Bike Path** Councilman Kizer moved to add shell sand to the Jungle Shores Bike Path to the elevation of the road. Mayor Pro Tem Moore seconded the motion, which was approved unanimously.
- H. First Reading of Ordinance No. 2019-26 to Grant to Dominion Energy, South Carolina, Inc., its successors and assigns, the non-exclusive right, power and authority to erect and to install, maintain and operate on, along, across, in, over, above, upon and under the streets, alleys and other public places of the Town: (1) Electric Lines, poles, wires, guys, push braces, transformers, appurtenant facilities; and (2) communication lines and facilities for any purpose and any use by the company or any designee, together with any necessary right of access thereto, for such period as the same is needed by the company to render service to its customers in the Town of Edisto Beach, South Carolina, from those facilities; to set the amount of franchise fees to be paid by Dominion Energy South Carolina, Inc. to the Town; if so required, to levy franchise fees on third parties selling electricity using the company's electric systems; to allow for the establishment of a fund and underground utility districts for electric non-standard service; be it ordained by the Mayor and Council of Edisto Beach in Town Council assembled Mayor Pro Tem Moore moved to approve the first reading of Ordinance No. 2019-26, seconded by Councilwoman Smyer and unanimously approved.
- I. First Reading of Ordinance No. 2019-27 to Grant to Berkeley Electric Cooperative, Inc., the non-exclusive right, power, and authority to erect and to install, maintain, and operate in, over, under, and upon the streets, alleys, and public places of the Town of Edisto Beach, its electric lines, poles, wires, guys, push braces, and appurtenant electric distribution facilities, whether used to render service to the Town or not, together with any necessary right of access thereto, for such period as the same are needed by the cooperative to render electric service to its customers in the Town of Edisto Beach, South Carolina; also to set amount of the franchise fee to be paid by Berkeley Electric Cooperative, Inc., to the Town of Edisto Beach, South Carolina Councilwoman Smyer moved to approve Ordinance No. 2019-27, seconded by Councilwoman Hornsby and approved unanimously.
- **J.** Hurricane Dorian Category G Beach Damages Councilman Kizer moved to approve the Town's request to apply for FEMA Category G funds for Hurricane Dorian. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.

- **K.** Wastewater Treatment Plant Aerator Councilwoman Smyer moved to approve the purchase of an aerator for the wastewater treatment plant at a cost of \$3,335.72 from Sewer R&R, seconded by Councilman Kizer and approved unanimously.
- **L. House Bill 4431, Business Licenses** Councilwoman Smyer moved that Council oppose House Bill 4431 which changes the method by which income is calculated for business licenses from gross income to net income and changes how cities address out-of-city businesses in the business license process. The Town would lose approximately 50% of its business license revenues if the bill were to pass. Councilman Kizer seconded the motion, which was unanimously approved.
- M. Selection Committee RFQ No. 2019-09 Stormwater Engineering "As Needed" Mayor Pro Tem Moore moved to approve the appointment of Councilwoman Hornsby, Iris Hill, Mark Aakhus and Bob Doub to the Selection Committee for RFQ No. 2019-09, Stormwater Engineering "As Needed." Councilman Kizer seconded the motion, which was approved unanimously.
- N. Selection Committee RFQ NO. 2019-10 Architect/Engineer New Town Hall Complex Councilwoman Smyer moved to approve the appointment of Mayor Darby, Councilman Kizer, Iris Hill, Patrick Brown, Mark Aakhus, George Brothers, Denney Conley and Patrick Zemp to the Selection Committee for RFQ No. 2019-10 Architect/Engineer, New Town Hall Complex. The motion was seconded by Councilwoman Hornsby. Mayor Darby went on to explain that a new Town Hall would not put the Town into debt but would be financed by a Capital Project Sales Tax from Colleton County. Councilwoman Smyer told those in attendance that while pursuing grant funding for beach renourishment it became evident how important "shovel ready" projects are in securing said funding. Mayor Darby called for the vote and the motion passed unanimously.

Committee Vacancies

- A. Beachfront Management Committee Mayor Pro Tem Moore moved to approve the application of Matthew Kizer to serve a second four-year term on the Beachfront Management Committee. Councilwoman Hornsby seconded the motion which was approved 4-0 with Councilman Kizer recused.
- **B.** The Image and Design of Edisto (TIDE) Committee Councilwoman Smyer moved to approve the advertising of the vacancy on the TIDE Committee. Councilman Kizer seconded the motion, which was approved unanimously.
- C. Zoning Board of Appeals Two applications were received for the vacancy created by the resignation of Joe Dreher from the ZBA, one from Pat Kostell and one from Ned Kuntz. Council voted by ballot and Mayor Pro Tem Moore moved to appoint Ned Kuntz to the Zoning Board of Appeals. Councilwoman Hornsby seconded the motion, which was unanimously approved.

Accommodations Tax Advisory Board

- **A.** Edisto Chamber of Commerce Off Season Marketing and Advertising 2019/2020 \$50,000 Councilman Kizer moved to approve the recommendation of the ATAX Board to grant the Edisto Chamber's request for \$50,000 to fund off season marketing and advertising. Councilwoman Smyer seconded the motion, which was approved unanimously.
- **B.** Town of Edisto Beach, Bay Creek Park Parking Lot Asphalt, \$150,000 Councilwoman Smyer moved to defer the recommendation of the ATAX Board to fund the paving of the Bay Creek Park parking lot until further information is received. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.

Mayor Darby congratulated Iris Hill on being recognized by the International City Managers Association for thirty years of service.
