TOWN OF EDISTO BEACH

AN ORDINANCE

ENACTING SECTION 26-59 RELATED TO POST DISASTER DEBRIS COLLECTION

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Town of Edisto Beach, South Carolina, in council duly assembled that Section 26-59 of the Town Code be enacted to read as follows:

Sec. 26-59 - Post disaster debris collection.

- (a) In the event of a natural or manmade disaster that has been declared a public emergency by the Mayor or other authorized official, the Town may, but is not required to, exercise its authority to implement the measures set forth herein. This section shall not be read to create any private rights nor does it obligate or create an affirmative duty for the Town to remove debris from private property or private roads.
- (b) Town Council shall have the authority and responsibility to protect the public health and safety. The Town Council shall have the authority to remove debris which poses an immediate threat to life, public health and safety, significant damage to improved public and private property, and the economic recovery of the Town.
- (c) The Town is hereby authorized to enter upon and remove debris from public and private roads, rights-of-way, storm drainage easements, and ingress/egress easements within Town limits, including private communities, for the purposes of emergency vehicle travel, stormwater conveyance, protecting public health and safety, facilitating response and recovery operations, and for any other purpose the Town Council determines is necessary to remove an immediate threat to life, public health and safety, significant damage to improved public and private property, and the economic recovery of the Town.

This ordinance shall take effect upon final reading.
