MINUTES DECEMBER 12, 2019 REGULAR TOWN COUNCIL MEETING 6:00 P.M.

Present: Jane S. Darby, Mayor, Crawford Moore, Mayor Pro Tempore, Susan Hornsby, Jerome Kizer and Patti Smyer, Council Members. *Quorum of Council Present*.

Pledge and Invocation

Councilwoman Smyer led those in attendance in the Pledge of Allegiance and an invocation.

Approval of Minutes

A. Regular Council Meeting Minutes, November 14, 2019 - Councilwoman Smyer moved to approve the minutes from the November 14th meeting, seconded by Councilwoman Hornsby and approved unanimously.

Proclamations and Presentations

A. Starfish Awards – Mayor Darby recognized Corey Merritt for sand blasting and painting the streetlight Christmas decorations at no charge. The following Town Hall employees were recognized for their help in getting the Christmas lights and decorations prepared and erected: Morgan Viars, Iris Hill, Mark Aakhus, Deborah Hargis, Paul Otte, Marshall Horstmann, Pete Lala, Alfred Meggett, Julian "Hoss" Meggett, Axavier Wright and Patrick Zemp.

Old Business

- A. Second Reading of Ordinance No. 2019-26 to Grant to Dominion Energy, South Carolina, Inc., its successors and assigns, the non-exclusive right, power and authority to erect and to install, maintain and operate on, along, across, in, over, above, upon and under the streets, alleys and other public places of the Town: (1) Electric Lines, poles, wires, guys, push braces, transformers, appurtenant facilities; and (2) communication lines and facilities for any purpose and any use by the company or any designee, together with any necessary right of access thereto, for such period as the same is needed by the company to render service to its customers in the Town of Edisto Beach, South Carolina, from those facilities; to set the amount of franchise fees to be paid by Dominion Energy South Carolina, Inc. to the Town; if so required, to levy franchise fees on third parties selling electricity using the company's electric systems; to allow for the establishment of a fund and underground utility districts for electric non-standard service; be it ordained by the Mayor and Council of Edisto Beach in Town Council assembled Councilman Kizer moved to approve the second reading of Ordinance No. 2019-26, seconded by Mayor Pro Tem Moore and unanimously approved.
- B. Second Reading of Ordinance No. 2019-27 to Grant to Berkeley Electric Cooperative, Inc., the non-exclusive right, power, and authority to erect and to install, maintain, and operate in, over, under, and upon the streets, alleys, and public places of the Town of Edisto Beach, its electric lines, poles, wires, guys, push braces, and appurtenant electric distribution facilities, whether used to

render service to the Town or not, together with any necessary right of access thereto, for such period as the same are needed by the cooperative to render electric service to its customers in the Town of Edisto Beach, South Carolina; also to set amount of the franchise fee to be paid by Berkeley Electric Cooperative, Inc., to the Town of Edisto Beach, South Carolina — Councilwoman Smyer moved to approve Ordinance No. 2019-27, seconded by Councilwoman Hornsby and approved unanimously.

C. Deer Study Results – Mayor Darby told those in attendance that the study done last month by Folk Land Management, Inc. showed that "from a biological perspective the deer are in good health and there is an absence of any signs of a major habitat destruction from over-population. Public safety issues by professional officials are not...at a high level of concern. Based upon our conversations, landscape damage by deer in certain areas of the town is a homeowner concern...I recommend that the Town discourage (or prohibit) the feeding of deer and other wildlife (except bird feeders) and encourage homeowners to landscape with plants that are resistant to deer browsing. These two steps could help alleviate some problems. I also recommend that the Town continue to monitor the deer herd on a routine basis through annual (or biannual) spotlight surveys." Councilwoman Smyer moved to continue to monitor the deer population as recommended, seconded by Councilwoman Hornsby and unanimously approved.

New Business

- **A.** Bank Depository Agreement Mayor Pro Tem Moore moved to approve extending the bank services agreement with Enterprise Bank of SC for an additional two years. The motion was seconded by Councilman Kizer and approved unanimously.
- **B.** Award of RFQ 2019-06 Parks Recreations Trails Master Plan Councilman Kizer moved to approve the award of RFQ 2019-06 to Toole Design Group, LLC and to authorize the Assistant Town Administrator to negotiate and execute said agreement for a cost not to exceed \$59,375. Councilwoman Hornsby seconded the motion which was unanimously approved. Assistant Town Administrator Mark Aakhus thanked Sue Keith, who was in attendance, for her assistance in securing grant support from the Legislative Delegation.
- C. Coastal Water Level Monitoring System for South Carolina Councilwoman Smyer moved to approve the Town's participation in the South Carolina Beach Advocates partnership with Schmidt Marine Technology Partners to fund half the cost of five (5) water level gauges to achieve increased coverage of water level (tide) gauges along the SC coast to supplement the NOAA gauges improving water level predications. The cost to participate is \$500 to be paid from local accommodations funds. Mayor Pro Tem Moore seconded the motion, which was approved unanimously.
- **D. 2020 Red Cross Blood Drive Date Requests** Councilman Kizer moved to approve the request from the Red Cross to hold blood drives at the Edisto Beach Civic Center with fees waived on the following dates: January 21, May 19, July 14 and October 13, 2020. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.

Committee Vacancies

A. The Image and Design of Edisto (TIDE) Committee – Councilwoman Smyer moved to approve the application of Elizabeth Daise to fill the vacancy on the TIDE Committee, seconded by Councilwoman Hornsby and approved unanimously.
