Councilman Moore led those present in the Pledge of Allegiance and an invocation.

Approval of Minutes

Councilwoman Smyer moved to approve the minutes of the December 12, 2019 Regular Council Meeting, seconded by Councilwoman Hornsby and approved 4-0.

Proclamations and Presentations

Mayor Darby recognized Utilities Director Patrick Zemp for exemplary service in identifying the source of a water billing issue for a customer in Island Cove. Mayor Pro Tem Moore read an email from Carl Nechtman expressing his thanks to Mr. Zemp. Mayor Pro Tem Moore also expressed his thanks to the entire Utilities Department for their hard work in correcting issues that occurred on Christmas Eve and Christmas Day and asked Mr. Zemp to relay thanks to his team.

New Business

- **A.** Resolution No. 2020-R01 Councilwoman Smyer moved to approve Resolution No. 2020-R01 Jury Box Resolution, seconded by Mayor Pro Tem Moore and approved 4-0.
- B. Mutual Aid Agreement Between the Town of Edisto Beach Police Department and the Colleton County Sheriff's Office Due to recent change in leadership, the Mutual Aid Agreement between the Edisto Beach Police Department and the Colleton County Sheriff's Office has been amended. Mayor Pro Tem Moore moved to approve the Mutual Aid Agreement, seconded by Councilwoman Hornsby and approved 4-0.
- C. Agreement Between Colleton County Sheriff's Office and the Town of Edisto Beach Police Department to Provide the Town of Edisto Beach with Victim Assistance Councilwoman Smyer moved to approve the Victim Assistance agreement between the Colleton County Sheriff's Office and the Town of Edisto Beach Police Department. Councilwoman Hornsby seconded the motion which was approved 4-0.
- **D.** Recurring Special Event Application, Edisto Chamber of Commerce, Edisto Road Race Mayor Pro Tem Moore moved to approve the application from the Edisto Chamber to hold the Edisto Road Race on March 21, 2020 beginning at 8:00 a.m. and starting in Wyndham. Councilwoman Smyer seconded the motion which was approved 4-0.
- E. Special Event Application, Animal Lovers of Edisto, Freezin' for a Reason Polar Puppy Plunge Councilwoman Smyer moved to approve the application from the Animal Lovers of Edisto to hold a

fundraiser on February 29, 2020 beginning at 11:00 a.m. in McConkey's parking lot. Councilwoman Hornsby seconded the motion, which was approved 4-0.

- F. May 2020 TIDE Committee Meeting Date Change Mayor Pro Tem Moore moved to approve the date change of the May 2020 TIDE Committee meeting from April 29th to May 6^{th} . Councilwoman Hornsby seconded the motion, which was approved 4-0.
- G. Bay Creek Park Rental Equipment Clause Regarding Dumpsters Councilwoman Hornsby moved to approve the modification of the Bay Creek Park Rental Equipment Clause to include the requirement for lessees of events with a projected attendance of 400 or more attendees to rent a temporary trash receptacle and/or dumpster. Mayor Pro Tem Moore seconded the motion, which was approved 4-0.
- H. Edisto Art Guild Arts in the Park 2020 Councilwoman Smyer moved to approve the request from the Edisto Art Guild to use Bay Creek Park on June 14, July 12 and August 9 and the Civic Center as an alternate location in case of inclement weather for their 2020 Arts in the Park program, and authorized Administrator Hill and Special Projects Coordinator Kelly Moore to act on the Town's behalf in the process. Mayor Pro Tem Moore seconded the motion which was approved 4-0.

Mayor Darby stated, "During the time of February budget adjustment, there was a box on InCode that was inadvertently not unchecked after the figures, so Administrator Hill caught the fact that she was inadvertently getting more money in each paycheck than she was actually due." As a means of settling this, since it is recognized that leave is the same as wages as far contractual matters, she is forfeiting 73.92 hours of Executive leave which equals to 9.24 days and this will settle the matter with the approval of Council. "That is my motion." Councilwoman Hornsby seconded the motion, which was approved 4-0.
