# MINUTES AUGUST 13, 2020 REGULAR TOWN COUNCIL MEETING 6:00 P.M.

Present: Jane S. Darby, Mayor, Crawford Moore, Mayor Pro Tempore and Jerome Kizer, Council Members, Councilmembers Susan Hornsby and Patti Smyer joined the meeting via conference call; *Quorum of Council Present*.

## Pledge of Allegiance and Invocation

Mayor Darby led those in attendance in person and virtually in the Pledge of Allegiance and an Invocation.

# Approval of Minutes

A. Regular Council Meeting Minutes, July 9, 2020 – Mayor Pro Tem Moore moved to approve the minutes of the regular Council meeting of July 9, 2020, seconded by Councilman Kizer and approved unanimously.

## **Proclamations and Presentations**

**A.** Starfish Award – Jim Johnson, Construction Board of Appeals – At the time of his passing, Mr. Johnson was a member of the Construction Board of Appeals. Mayor Darby thanked his family for his contribution and asked that the Starfish Award be presented to them.

# Old Business

A. RFQ 2019-10 Architectural Service for Edisto Beach Town Hall — On May 14, 2020, Town Council approved the awarding of the contract to Coast Architects and authorized the Town Administrator to negotiate and execute said contract. The Town was unable to negotiate the terms of the contract. Councilman Kizer moved to withdraw the contract to Coast Architects and award the contract to the next highest ranked firm of Rosenblum Coe and authorize the Town Administrator to execute the agreement. Councilwoman Smyer seconded the motion, which was unanimously approved.

#### **New Business**

- **A. Emergency Ordinance No. 2020-22 COVID-19** Emergency Ordinance 2020-21 was approved July 1, 2020 and expires August 30, 2020. Councilwoman Smyer moved to approve Emergency Ordinance #2020-22 extending the state of emergency and continuing the face covering requirement. Councilwoman Hornsby seconded the motion, which was approved unanimously.
- **B. Personnel Manual** The Municipal Association of South Carolina recommends the personnel manual be reviewed by a labor attorney every 5 years. Councilman Kizer moved to approve the new manual dated August 13, 2020 and revoke the old manual, seconded by Mayor Pro Tem Moore and unanimously approved.
- C. 2020-2023 Edisto Beach Strategic Plan Councilwoman Hornsby moved to approve the strategic plan of the Town of Edisto Beach for the FY 2020-2023, seconded by Councilwoman Smyer and approved unanimously.

- **D.** Change Order No. 4 Mitchell Construction Renovation of Fire Barracks (\$320) Councilman Kizer moved to approve Change Order #4 on the renovation of the fire barracks with Mitchell Construction for a \$320.00 reduction. The amended contract price after the decrease is \$118,960. Mayor Pro Tem Moore seconded the motion, which was approved unanimously.
- E. Recurring Special Event Form, 30<sup>th</sup> Annual Edisto Christmas Parade Mayor Pro Tem Moore moved to approve the special event form for the 30<sup>th</sup> Annual Christmas parade to be held on December 12, 2020. Councilman Kizer seconded the motion. Mayor Pro Tem moved to amend the motion to include the provisions depending on the conditions and the observation of CDC guidelines, seconded by Councilman Kizer. Mayor Darby called for the vote on the amended motion and it was unanimously approved.
- **F. Recurring Special Event Form, 2020 Fall Festival** Councilman Kizer moved to approve the special event form to hold the 2020 Fall Festival on October 17, 200 in front of the Jungle Road plaza. Mayor Pro Tem Moore seconded the motion. After discussion Mayor Darby called for the vote and the motion was defeated, 0 5, with Council members citing the uncertainty of COVID-19 as the reason. Mayor Darby congratulated new Chamber Director Chelsea Ward on her hard work.

#### Committee Vacancies

A. Zoning Board of Appeals -2 vacancies - Councilwoman Smyer moved to approve the advertisement of two vacancies on the Zoning Board of Appeals, seconded by Mayor Pro Tem Moore and approved unanimously.

## **Accommodations Tax Advisory Board**

- **A.** Edisto Art Guild Art in Public Places \$9,605 Mayor Pro Tem Moore moved to defer the Edisto Art Guild request for Art in Public Places in the amount of \$9,605 until September 2020. Councilwoman Hornsby seconded the motion which was unanimously approved.
- **B.** Edisto Chamber of Commerce Off Season Marketing \$50,000 Councilman Kizer moved to approve the recommendation of the ATAX board to grant the request for \$50,000 for off season marketing from the Edisto Chamber of Commerce, seconded by Councilwoman Smyer and approved unanimously.
- **C. Edisto Beach Fire Department-\$5,504** Councilwoman Smyer moved to approve the recommendation of the ATAX Board to award \$5,504 in ATAX funds to purchase furniture for the Edisto Beach Fire Department barracks. Councilman Kizer seconded the motion, which was unanimously approved.
