**Call to Order:** Chairman Oakley called the meeting to order.

**Approval of Minutes:** Judith Blancett moved to approve the minutes of February 1, 2018, seconded by Leslie Varner Hurley and approved 5– 0.

**Resignation of Pieter Knot, Hospitality/Lodging** – Mr. Knot has resigned his position due to a change in work status.

**Election of new Vice Chairperson** – Due to Mr. Knot’s resignation, Van Maxwell nominated Leslie Varner Hurley as Vice Chairperson of the ATAX Committee. Stephanie Jumper seconded the motion, which was approved 5 – 0.

**Expiration of three terms on August 1, 2018** – The terms of Matthew Kizer (Hospitality/Lodging), Judith Blancett (Culture and Arts) and Paul Oakley (At Large) expire on August 1, 2018.

**ATAX Fund Balance** – Leslie Varner Hurley moved to approve the ATAX Fund Balance of \$263,293.78, seconded by Judith Blancett and approved 5 – 0.

**ATAX Applications –**

**Town of Edisto Beach Police Department, \$9,000** – Police Chief George Brothers presented the application on behalf of the Police Department. The unencumbered balance shown on the ATAX Fund Balance sheet (\$1,676.98) will be used to fund the beach patrol when it starts at the end of May. Van Maxwell moved to approve the full amount requested for the beach patrol, \$9,000, seconded by Leslie Varner Hurley and approved 5 – 0.

**Town of Edisto Beach Bell Property Annual Bond Debt, \$50,000** – Town Administrator Iris Hill presented the application on behalf of the Town of Edisto Beach. Leslie Varner Hurley moved to approve the full amount requested by the Town (\$50,000), seconded by Judith Blancett and approved 5– 0.

Stephanie Jumper moved to adjourn the meeting, seconded by Van Maxwell and approved 5 – 0.
