Pledge of Allegiance and Invocation

Councilman Jerome Kizer led those present in the Pledge of Allegiance and an Invocation.

Approval of Minutes

A. Regular Council Meeting Minutes, December 9, 2021 – Councilman Kizer moved to approve the regular Council meeting minutes from December 9, 2021. Councilman Watts seconded the motion which was unanimously approved.

Proclamations and Presentations

Mayor Moore recognized Mr. Cameron Andrews with a Starfish Award for serving two terms on the Image and Design of Edisto (TIDE) Committee for the Town of Edisto Beach. Mr. Andrews accepted his award at the meeting.

Mayor Moore recognized Mr. Bill Davies with a Starfish Award for serving two terms on the Beachfront Management Committee of the Town of Edisto Beach. Mr. Davies was not present and received his award in the mail.

Mayor Moore recognized Ms. Conchi Gelner with a Starfish Award for her exceptional aptitude at volunteerism for the Town of Edisto Beach. Ms. Gelner was not present and received her award in the mail.

<u>Public Comment</u> – There were no comments from the audience.

Old Business

A. Ordinance No. 2021-13 Temporary Moratorium to be reviewed every 30 days until resolved. — Mayor Moore informed the audience that the South Carolina Department of Health and Environmental Control had reviewed and completed the permit. Mayor Moore also informed that audience that the bid package was scheduled to be submitted to the SC Rural Infrastructure Authority and that construction is to begin in December 2022.

B. **Memorial Bricks Campaign** – Councilman Watts moved to approve staff recommendation that the brick memorials be placed at Jungle Road Park and that the bid be awarded to Brickmarkers. Councilman Kizer seconded the motion which was unanimously approved.

- **G. Encroachment Agreement 2704 Point Street** Mayor Moore moved to approve the encroachment agreement for 2704 Point Street. Councilman Watts seconded the motion which was unanimously approved. Mayor Pro Tem Kizer recused himself from voting on this item.
- H. First Reading of Ordinance No. 2022-03 to Authorize the Town of Edisto Beach to Convey Certain Real Property and Authorize the Mayor to Execute the Quit Claim Deed Mayor Pro Tem Kizer moved to approve the first reading of Ordinance No. 2022-03 to authorize the Town of Edisto Beach to convey certain real property and authorize the Mayor to execute the Quit Claim Deed. Councilman Watts seconded the motion which was unanimously approved.
- I. Request for Qualifications for Edisto Beach Municipal Judge Councilman Watts moved to approve issuing a request for qualifications for the Edisto Beach Municipal Judge. Mayor Pro Tem Kizer seconded the motion which was unanimously approved.
- J. 1502 Palmetto Boulevard Water Leak Adjustment Request Mayor Pro Tem Kizer moved to deny the water leak adjustment request for 1502 Palmetto Boulevard. Councilman Watts seconded the motion which was unanimously approved.
- **K.** Lot Fill Impacts Building Code Administrator Patrick Brown discussed including lot fill impacts on lot clearing permits. This item was for informational purposes only, no action was taken.
