**“Drive-On” Dock Resolution**

**WHEREAS**, the Town of Edisto Beach has a water rescue boat that is docked at Bay Creek Park; and

**WHEREAS**, the time to respond to calls for assistance is critical; and

**WHEREAS**, the boat has to be taken out of service periodically to maintain the hull; and

**WHEREAS**, by utilizing a “drive-on” dock, the boat can stay in service for longer periods of time; and

**WHEREAS**, a “drive-on” dock improves response time during critical water rescue situations; and

**WHEREAS**, Department of Natural Resources Water Recreation Funds are available and may be utilized for the purchase of said “drive-on” dock; and

**WHEREAS**, the Colleton County Legislative Delegation can authorize spending of Water Recreation funds.

**NOW THEREFORE**, be it resolved that the Town of Edisto Beach Town Council requests Colleton County Legislative Delegation authorize the purchase of a “drive-on” dock at Bay Creek Park using Water Recreation Funds.
