AN ORDINANCE

TO AMEND SEC. 18-53(m) TO EXTEND THE EXPIRATION DATE FOR THE REGULATIONS GOVERNING MOBILE VENDING

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF EDISTO BEACH THAT section 18-53(m) is amended to read as follows:

**Sec. 18-53. Mobile Vending; Regulations.**

(m) *Expiration date.* The provisions of Section 18-53 shall expire on Dec. 31, 2015. This provision, commonly known as a "sunset provision," is included in this ordinance to ensure that this ordinance, its effectiveness and its desirability will be reviewed by the Town Council.

This ordinance shall take effect upon adoption.
