AN ORDINANCE

To Amend Article IV of Chapter 14 of the Town of Edisto Beach Code of Ordinances to Enact Section 14-117 Related to Severability

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Town of Edisto Beach, South Carolina, in council duly assembled that Article IV of Chapter 14 of the Town's Code be amended to enact Section 14-117 which shall read as follows:

**Section 14-117. Partial Invalidity and Severability.**

*If any part of this Article IV is declared invalid, the remainder of Article IV shall not be affected and shall remain in force.*

This ordinance shall take effect upon final reading.
