**Town of Edisto Beach  
A Resolution**

**WHEREAS**, the Law Enforcement Assistance and Support Act, S.C. Code Ann. §23-20-10, et seq., provides for agreements to be entered into on behalf of a law enforcement agency in this State for the purpose of providing the proper and prudent exercise of public safety functions across jurisdictional lines, including, but not limited to, multijurisdictional task forces, criminal investigations, patrol services, crowd control, traffic control and safety, and the other emergency service situations. Such agreements must not be permitted for the sole purpose of speed enforcement; and

**WHEREAS**, a mutual aid agreement entered into on behalf of a law enforcement authority must be approved by the appropriate governing body of each concerned county, incorporated municipality, or other political subdivision of this State, except that a County Sherriff, as an elected official whose office was created by the Constitution and general law of this State, is not required to seek approval from the Sherriff's governing body in order to participate in said mutual aid agreements; and

**WHEREAS**, the Charleston County Sherriff's office and the Town of Edisto Beach desire to enter into such an agreement for all proper purposes provided for in the Law Enforcement Assistance and Support Act.

**NOW THEREFORE**, in consideration of the mutual covenants and promises contained in the Law Enforcement Mutual Aid Agreement, it is the intent of the parties to share jurisdiction under the aforementioned agreement to the fullest extent permitted under South Carolina law.
