Subcommittee Updates:

Bay Creek Park Restroom Committee

Zoning Rewrite Subcommittee

3747 Docksite Road & 3748 Docksite Road – Ms. Cathy Price – Property Line Abandonment

Ms. Price has made an application to the Planning Commission to abandon the existing lot line between Lot 42 and Lot 43 which is located in the C-2 district. Member Cannon moved to approve the application followed by a second provided by Member Cumalander. Chairman Andrews called for questions and discussion. There being none, a vote was taken and it was **unanimous to approve.**

<u>Lot 7, Block UU, Lot 7, Block YY and Lot 8, Block YY – Town of Edisto Beach - Approve Ordinance to re-zone to PB, Public & Semipublic District</u>

The Town of Edisto Beach has made a request to approve the Ordinance that rezones three (3) lots it owns to PB, Public & Semipublic District from R-1, Low Density Residential District. Member Blauch moved to approve the Ordinance followed by a second from Vice Chairperson McCarley. Chairman Andrews called for questions and discussion. There being none, a vote was taken and it was unanimous to approve.

<u>Tracts L & M - Wyndham Ocean Ridge - Expired Development Plan Revised and Amended</u>

The Town of Edisto Beach has made a request to approve the Ordinance that rezones Tracts L & M because the Town's Official Zoning Map and Official PUD Map reflects an expired development plan on these two (2) Tracts. Member Blauch moved to approve the Ordinance followed by a second from Member Hackett. Chairman Andrews called for questions and discussion. There being none, a vote was taken and it was **unanimous to approve.**
