TOWN OF EDISTO BEACH 2024-2026 Emergency Access Decals

Below is information regarding emergency access decals for 2024-December 31, 2026. Depending upon when the decal was issued, Emergency Access Decals will be effective for <u>three years</u>, or depending upon date of issuance. All decals, regardless of the date issued, will expire on December 31, 2026.

- 1. In the event of a government-ordered evacuation, Emergency Access decals will streamline re-entrance to Edisto Beach; however, they are not required if proof of ownership as defined below is provided.
- 2. Full-time resident owners may register two vehicles. Those with extenuating circumstances requiring additional decals will be individually considered. Owners of rental properties may receive one decal. Interval ownership properties must designate one person to receive a decal and only one decal per property will be provided. Temporary, event-specific passes may be issued to renters and owners of rental properties if and when the need arises.
- 3. Those receiving decals must provide documentation of vehicle ownership.
- 4. Owners of multiple properties are permitted only two decals.
- 5. You may drop-off your completed application with supporting documentation to Town Hall, or mail to Town Hall at 2414 Murray Street, Edisto Beach, SC 29438. Decals will be issued only if all required documentation is submitted.
- 6. Town Hall office hours are 8:00 a.m. to 4:30 p.m., Monday through Friday, except for holidays.
 - What do I need as proof of ownership? To prove ownership and receive two (2) decals, you must show a driver's license or voter ID with an Edisto Beach address, or two forms of ownership documentation such as a current utility bill and tax notice. Vehicles should be registered to the owner.
 - Where do I place the decal on my vehicle? Decals should be placed on the lower left corner of the windshield.
 - May I give my decal to a friend or family member? You may not sell or give away your emergency decal. The decal numbers can be tracked to the vehicle registered, and you will lose your decal privileges if you are found to have fraudulently sold or given out your decal.
 - What if I only live at Edisto Beach part-time or rent my property? A property owner who owns a property which is never rented and which they occupy part-time is entitled to one emergency access decal. In no case shall more than one decal be issued for a part-time residential property owner or an owner of rental properties. Long-term renters and owners of rental properties will be issued a temporary pass if and when a need arises.
