

LEAD AND COPPER SAMPLING RESULTS July-December 2021 90TH PERCENTILE

Below are the individual results for each sample site from the July -December 2021 monitoring period.

The 90th percentile for lead was 0.0047 mg/L and for copper 0.17 mg/L for the 40 samples analyzed.

The public water system must deliver Customer Notice of Lead and Copper Results in Drinking Water within 30 days of receiving these test results from DHEC. This notice must contain the content as outlined in State Primary Drinking Water Regulation R.61-58.11.G(4)(c):

- the results of lead tap water monitoring for the tap that was tested
- an explanation of the health effects of lead
- list steps consumers can take to reduce exposure to lead in drinking water
- contact information for the water utility
- the maximum contaminant level goal and the action level for lead and the definitions for these two terms from R.61-58.12.C(3).

As per R.61-58.11.G(4)(d) the consumer notice must be provided to persons served at the tap that was tested, either by mail or by another method approved by the Department. For example, upon approval by the Department, a non-transient non-community water system could post the results on a bulletin board in the facility to allow users to review the information. The system must provide the notice to customers at sample taps tested, including consumers who do not receive water bills. After notification is completed the Consumer Information Notice Form must be filled out and returned to to DHEC.

The next sampling schedule is 20 samples to be collected during the 06/01/2024 - 09/30/2024 monitoring period.
