The month ending May 31, 2022 financial report provides in the General Fund 94.64% of the budgeted revenues were received and 84.22% of budgeted expenditures were spent.

In the Water Department, 75.15 % of budgeted revenues have been received and 76.14% expenditures have been spent and in the Wastewater Department, 83.76% of the budgeted revenues have been received and 70.21% of the budgeted expenditures have been spent.
