MINUTES **January 12, 2017** **REGULAR COUNCIL MEETING** **6:00 P.M.**

Present: Jane S. Darby, Mayor, Susan Hornsby, Mayor Pro Tempore, Jerome Kizer, Crawford Moore, and Patti Smyer, Council Members;
Quorum of Council Present.

Mayor Darby called the meeting to order and Councilman Moore led those in attendance in an invocation and the Pledge of Allegiance.

Approval of Minutes

Councilwoman Smyer moved to approve the minutes of the Public Hearing held November 10, 2016, seconded by Mayor Pro Tem Hornsby and approved unanimously. Councilman Kizer moved to approve the minutes of the Regular Council Meeting held December 8, 2016, seconded by Councilman Moore and approved unanimously.

Proclamations and Presentations

Maxine Burton was recognized with a pin and certificate commending her on ten years' service to the Town of Edisto Beach.

Mayor Darby introduced Anna Pinckney from SCANA who will be taking Jan Meier's place when she retires in March. Mayor Darby welcomed Ms. Pinckney and told her the Town was looking forward to working with her.

Old Business

A. Second Reading of Ordinance 2016-27 to adopt the amended budget for fiscal year 2016-17 for the Town of Edisto Beach, South Carolina for the Fiscal Year Beginning July 1, 2016 and Ending June 30, 2017 – The Town had to transfer \$1,000,000 from prior year funds to the operating budget to offset costs associated with Hurricane Matthew. This transfer increases the Town's budget by 16.1% and amends the revenues and expenditures to \$7,190,661. Seventy-five percent of this funding should be reimbursed by FEMA. Councilman Moore moved to approve the second reading of Ordinance No. 2016-27, seconded by Councilman Kizer. The motion was approved unanimously.

B. Second Reading of Ordinance 2016-24 a Second Supplemental Ordinance Providing for the Issuance and Sale by the Town of Edisto Beach, South Carolina of Combined Water and Sewer System Revenue Bonds; and other Matters Relating Thereto – The Water and Sewer Committee discussed the revenue bond and recommends Council move forward with this bond issuance and consider an insured bond. Councilwoman Smyer moved to approve the second reading of Ordinance No. 2016-24. The motion was seconded by Councilman Kizer and unanimously approved.

C. State Revolving Fund/Rural Water Infrastructure – The Water and Sewer Committee met on December 16, 2016 and discussed the possibility of extending front beach sewer by utilizing state revolving funds and/or a grant from the South Carolina Rural Infrastructure fund. They unanimously approved to table this issue until further notice. Mayor Pro Tem Hornsby moved to approve the recommendation of the Water and Sewer Committee to table the issue. Councilman Moore seconded the motion. Councilwoman Smyer mentioned that the extension of the front beach sewer would not help property owners affected by Hurricane Matthew. Those property owners who are replacing septic tanks would have to do that prior to tying in, since the sewer project would take several years. Mayor Darby called for the vote and the motion was unanimously approved.

New Business

A. Resolution No. 2017-R01 Jury Box

Resolution – Councilman Kizer moved to approve Resolution No. 2017-R01, the Jury Box Resolution. The motion was seconded by Councilwoman Smyer and unanimously approved.

B. 2017 Legislative Initiatives – Councilman Moore moved to approve the 2017 Legislative Initiatives, which are as follows, and include **in bold**:

- State Accommodations Tax – Edisto Beach is the only coastal town that does not receive greater than \$900,000 in ATAX so the Town is required to have TERC oversight. Edisto Beach should be exempted from this oversight and treated the same as other coastal communities.
- Beach Nourishment – Promote a state permanent funding source for beach nourishment
- Flexible Permitting – Recommended allowing for a flexible construction window which provides for cost savings **while continuing to protect land and marine wildlife.**
- Local Government Fund – Promote fully funding the LGF

Councilwoman Smyer seconded the motion, which was unanimously approved.

C. Thomas and Hutton Work Authorization

#16-02 – Councilwoman Smyer moved to approve work authorization #16-02 to provide technical specifications to replace existing booster pumps at the ground storage tank at a lump sum cost of \$1,200 to be paid from Water R & R. The Water and Sewer Committee recommends the Town seek bids to determine if the cost is feasible to replace the booster pumps. Councilman Kizer seconded the motion, which was unanimously approved.

D. Wharton Smith Change Order No. 1 –

Councilman Moore moved to approve the change order submitted by Wharton Smith increasing the original contract amount of \$90,000 by \$332,000 for a revised contract amount of \$422,000 to provide 60% construction documents for the water system improvement project and authorize the Mayor to execute the change order. This will be funded by the revenue bond. The motion was seconded by Councilwoman Smyer and unanimously approved.

E. Emergency Purchase Orders – Hurricane Matthew –

The Town's emergency purchase

policy requires the following be read into the minutes:

- a) Jungle Shores 6" Water Main - \$7,125.00
- b) Wellfield off Palmetto Road - \$12,500.00
- c) Wellfield Wells #4 and #5 - \$13,525.00
- d) Palmetto Boulevard from 100 – 1000 and Point Street - \$691,792.50

Councilman Kizer moved to approve the emergency purchase orders, seconded by Councilwoman Smyer and approved unanimously.

F. Proclamation No. 2017-P02 Municipal Association Legislative Initiatives –

Councilman Moore moved to approve the Proclamation supporting the Municipal Association's legislative initiatives. The motion was seconded by Councilman Kizer and unanimously approved.

G. Agreement between Colleton County Sheriff's Office and the Town of Edisto Beach Police Department to Provide the Town of Edisto Beach with Victim's Assistance –

Councilwoman Smyer moved to approve the agreement for victim's assistance between the Edisto Beach Police Department and the Colleton County Sheriff's Office. Mayor Pro Tem Hornsby seconded the motion, which was unanimously approved.

H. Noise Ordinance Variance – Town of Edisto Beach –

In order to complete the beach nourishment project within the permitted time frame, it is necessary for the contractor to work 24 hours a day. This involves lights on the beach in the work area and heavy equipment that will have audible backup alarms. Councilwoman Smyer moved to approve the noise ordinance variance for the project, seconded by Councilman Moore and approved unanimously.

I. Hurricane Matthew Recovery Update –

Town Administrator Iris Hill provided a PowerPoint on the Town's post-Matthew recovery. The Town of Edisto Beach requested public assistance on October 5, 2016 and the kickoff meeting with FEMA was on November 15. FEMA threshold limits are modified every year. The small project thresholds include anything between than \$3,040 and \$121,800 and a large project is greater than \$121,800. Emergency protective measures, which include all force accounts (labor and equipment), total \$112,454.00. The non-federal share is \$28,113.00 and the federal share is \$84,340.00. The Town has not received any worksheets back from FEMA except for the emergency berm. This project cost \$712,404.00. The non-federal share is \$178,101.00 and the federal share is \$534,303.00. The state

Department of Transportation contractor completed all the debris removal on Edisto Beach except for in Wyndham/Ocean Ridge. To date the non-federal share is \$12,943.00. The DOT will submit paperwork to FEMA and the Town will pay the 15% once they receive the money from FEMA. The debris removal in Wyndham/Ocean Ridge is completed, Colleton County handled that portion and no invoices have been received to date. The draft project worksheets on beach nourishment have been received from beach specialists. The Town Administrator, along with Coastal Science and Engineering, is currently reviewing the worksheets. The costs are estimated at \$1,944,419. The non-federal share is \$486,104 and the federal share would be \$1,458,314. The Town has already paid the non-federal share. All beach accesses were impacted in some way and the Town will be going out for bids on repairing them. Repairs may include installing rope fencing, putting back all amenities (signs, life rings, bike racks, benches). The Town has \$204,308 of donated resources, which would offset our non-federal share. The Jungle Shores waterline was \$7,125.00 and our non-federal share was \$1,781.00. The Town is getting quotes for the street repairs. Wells #4 and #5 cost \$13,525 and \$12,500 plus an additional invoice for electrical work. American Engineering checked the impellers and lift stations. The Town is still evaluating the damage. The Wastewater Treatment Plant also had sand intrusion, which could have impacted the capacity. The Town is currently in the process of having the sludge surveyed to see if there was an impact from the storm. The Town received a grant to repair two walkovers. The fence at Bay Creek Park was damaged and repaired. Generator repair at Well #6 has been completed. The bike path was cleared by the Fire Department and Public Works Department. There were approximately 50 water meters that the Utilities Department could not locate after Hurricane Matthew and are in the process of locating. The Town will obtain GPS coordinates on all meters.

J. Beach Nourishment Update –Steven Traynum from Coastal Science and Engineering provided an update on the beach nourishment project. The construction portion of the project has begun. Crowder Construction from Charlotte NC is the contractor for the groin lengthening and Marinex from Charleston is the contractor for the dredge. Both are completely mobilized on site, minus the dredge, which should arrive in the next week. Crowder is bringing in approximately 150 tons of rock every day. To date, repairs have been completed at groins 28 and 29. Rock has been added at groins 1 and 2. The repairs were grouted

at groins 28, 1 and 2. Rock is being stockpiled at beach access 13. Equipment is being staged on the north side of Finns. Mattresses, to be used in groin extensions, should be on-site in the next week. Extensions will start around groin 13/14, with the contractor completing some of the shorter extension before the nourishment begins. Once the nourishment begins, the longer sheet piling extensions will be done. The contractor for the dredge has pipe coming on the beach at the 500 block, which is where the nourishment is due to start. The contractor anticipates taking 2 to 3 days per cell with good weather and no equipment issues. The nourishment will move north towards Finns and will take two to three weeks. They will continue to the north to the State Park, and then move to the south.
