MINUTES January 11, 2018 REGULAR COUNCIL MEETING 6:00 P.M.

Present: Jane S. Darby, Mayor, Crawford Moore, Mayor Pro Tempore, Susan Hornsby, Jerome Kizer, and Patti Smyer, Council Members; *Quorum of Council Present*.

Due to Mayor Darby being stuck in traffic on her way back from Columbia, Mayor Pro Tem Crawford Moore called the meeting to order and led those present in the Pledge of Allegiance and an invocation.

Councilwoman Hornsby moved to amend the agenda to include two items in the Executive

Session: b. Legal Advice Regarding Lawsuit involving Property Lot 7 Block UU, Lot 7 Block YY and Lot 8 Block YY [SC Code 30-4-70a (2)] and c. Discussion about contractual negotiations with Wharton Smith related to proposed R/O facility construction [SC Code 30-4-70a Councilwoman Smyer seconded the motion, which was approved 4 - 0. Town Attorney Bert Duffie told those in attendance that no action would be taken on the items added to the agenda. Amended agendas were provided to those in attendance after the vote.

Approval of Minutes

Councilwoman Smyer moved to approve the minutes of the December 14, 2017 Council meeting, seconded by Councilman Kizer and approved 4-0.

Proclamations and Presentations

A. Starfish Awards

- **1. Bob Doub** Utilities Director Bob Doub was recognized for his award of System Manager of the Year by the South Carolina Rural Water Association.
- **2. George Brothers** Police Chief Brothers was recognized with a Lifetime Achievement Award from the South Carolina Law Enforcement Officers' Association.
- **3. Deborah Hargis –** Municipal Clerk Deborah Hargis was recognized for serving on the Board of Directors for the SC Municipal Human Resources Association.
- **4. Iris Hill** In the December issue of The Colletonian, Town Administrator Hill was recognized for her tireless efforts in the beach renourishment.
- **5. Danielle Messer** Building and Zoning Inspector Danielle Messer was recognized for putting together flood information to be included on the Town website.
- **6. Kelly Moore** Kelly was recognized for making The Market and Mingle Christmas event a great success thanks to her quick, decisive action in changing the venue from Bay Creek Park to the Civic Center.
- **7. Krystal Parsons** Clerk of Court Krystal Parsons was recognized for her diligence in drastically reducing the number of outstanding parking tickets.
- **8. Patrick Zemp** Over the Thanksgiving holiday while Utilities Director Doub was out of town, Patrick Zemp pulled samples and took them to Summerville so that the boil water notice that had been issued could be lifted as quickly as possible.

Old Business

A. Second Reading of Ordinance No. 2017-34 to Amend Article IV of the Town of Edisto Beach Code of Ordinances to Enact Section 14-117 Related to Severability - Councilman Kizer moved to approve the second reading of Ordinance No. 2017-34 to Amend Article IV of the Town of Edisto Beach Code of Ordinances to Enact Section 14-117 Related to Severability. The motion was seconded by Councilwoman Hornsby and approved 4 – 0.

New Business

- **A.** Resolution No. 2018-R01 Jury Box Resolution Councilwoman Smyer moved to approve Resolution No. 2018-R01, which reads in part, "...the 2018 Jury Box has been prepared pursuant to the requirement of Act #480 of 1980 and is now ready for use." Councilwoman Hornsby seconded the motion and it was approved 4 0.
- **B.** Jeremy Cay Beach Renourishment Project - The Town received notice from the community of Jeremy Cay at Edingsville Beach, which is in the process of obtaining a permit from DHEC OCRM for emergency beach renourishment. renourishment work was necessitated as a result of beach and dune damage caused by Hurricane Matthew and Tropical Storm Irma. If all goes to plan, the project is expected to take place between now and March 15, 2018 covering a portion of Edingsville Beach. Jeremy Cay is asking to participate in the Town's Beachfront Management Committee planning/meetings. Since Council is not formally appointing a Committee member, no action is needed on this item.
- C. Award of RFP No. 2017-13 Financial Statement Preparation and Audit Services Councilwoman Smyer moved to award RFP No. 2017-13 to K. Eve McCoy, and authorize the Town Administrator to execute a two-year contract. Councilwoman Hornsby seconded the motion, which was approved 4 0.
- D. Agreement Between Colleton County Sheriff's Office and the Town of Edisto Beach Police Department to Provide the Town of Edisto Beach with Victim's Assistance Councilman Kizer moved to approve the agreement between the Colleton County Sheriff's Office and the Town of Edisto Beach Police Department to Provide the Town of Edisto Beach with Victims' Assistance, seconded by Mayor Pro Tem and approved unanimously.
- **E. TIDE Committee Recommendations** At the November 2017 meeting, the TIDE Committee recommended that Council address the issue on

- the bike path between 3500 to Sunset Street. The Committee suggests increased drainage or elevating the path, or a combination of both, possibly in conjunction with the upcoming utility The TIDE Committee also unanimously recommended Council re-visit the previous recommendation on beach accesses 2, 5, 6, 20 and 29 and establish a timeline of March 15th for the completion of this project. Councilwoman Smyer moved to recommend to the TIDE Committee the following: 1) The TIDE Committee provide a prioritized list of projects to be addressed 2) Look at funding for prioritized projects once the federal projects are completed. Councilman Kizer seconded the motion, which was unanimously approved.
- **F.** Recurring Special Event Form Councilwoman Smyer moved to approve the Recurring Special Event Form, a one-page annual event renewal form for event holders who hold special events for three consecutive years or more at the same location and recurring timeframe. Mayor Pro Tem Moore seconded the motion, which was approved unanimously.
- Resolution No. 2018-R03 to Oppose Seismic Testing and Offshore Drilling **Activities – Mayor Darby moved to provisionally** approve Resolution No. 2018-R03 to Oppose Seismic Testing and Offshore Drilling Activities, with the stipulation that after the conference call scheduled for Friday, January 12, 2018 at 3:30 p.m. and in the judgement of the Town Attorney, the Town Administrator and the Mayor, if there is any hesitation about any adverse impact to Edisto Beach, the Resolution will be brought back before Council in February. Councilwoman Smyer Councilwoman Hornsby seconded the motion. expressed her concern with being part of a lawsuit, as did Councilman Kizer. The motion failed, 2 - 3, with Councilwoman Hornsby, Councilman Kizer and Mayor Pro Tem Moore voting against the motion.

Planning Commission

A. The Edisto Marina Association – Expansion Request – Councilwoman Hornsby moved to approve the request from the Edisto Marina Association to expand the number of member slips and added transient slips in front of the fuel dock. The parking plan has been updated, as requested by the Planning Commission. Councilman Kizer seconded the motion, which was unanimously approved.
