EDISTO RECIPES

Irish Ginger Snaps

1 cup white sugar

1 egg

1/4 teaspoon salt

34 cup shortening

2 cups all-purpose flour

½ teaspoon baking soda

1 teaspoon ground cloves

1 teaspoon ground ginger

1 teaspoon ground cinnamon

Preheat oven to 350 degrees. Cream sugar, egg, salt and shortening together. Add flour, baking soda and spices. Mix well. Roll teaspoonfuls of dough into balls and roll the balls in sugar. Bake at 350 degrees for 5 to 6 minutes.

MINUTES JANUARY 10, 2019 REGULAR TOWN COUNCIL MEETING 6:00 P.M.

Town of Edisto Beach Town Hall 2414 Murray Street Edisto Beach, SC 29438

Present: Jane S. Darby, Mayor, Crawford Moore, Mayor Pro Tempore, Susan Hornsby and Patti Smyer, Council Members; *Quorum of Council Present*. Absent: Jerome Kizer, Council Member.

Councilwoman Hornsby led those present in the Pledge of Allegiance and an invocation.

Approval of Minutes

A. Regular Council Meeting Minutes, December 13, 2018 – Councilwoman Smyer moved to approve the minutes of the December 13, 2018 Council minutes, seconded by Councilwoman Hornsby and approved 4-0.

Proclamations and Presentations

A. Starfish Awards – Natalie Kantz – At the Council worksession, Mayor Darby recognized Natalie Kantz, Public Works Supervisor, with a Starfish Award. The Image and Design of Edisto (TIDE) Committee nominated Natalie for, "her outstanding service to the Town of Edisto Beach. Over the past year Ms. Kantz led efforts by her team to maintain and continuously improve the appearance and function of the beach access areas, parks, the bike trail and the roads and right-of-ways...We thank her for her outstanding contributions to our beach community."

Old Business

A. Second Reading of Ordinance No. 2018-28 to Amend Sections 82-32(c)(1) related to Provisions of Temporary Use of the Town Water System to Contractors and to Amend the Fees – Mayor Pro Tem Moore moved to approve the second

reading of Ordinance No. 2018-28 to Amend Section 82-32(c)(1) related to Provisions of Temporary Use of the Town Water System to Contractors and to Amend the Fees. This increases the temporary use fee from \$50.00 to \$75.00 and 1,000 gallons from \$2.00 to \$5.00. These rates have not been adjusted since 1990 and adjustments are needed to account for the new rates associated with the water improvements. Councilwoman Hornsby seconded the motion which was approved 4-0.

B. Second Reading of Ordinance No. 2018-27 to Amend Sections 86-214(a)(16), 84-214(a)(17) of the Town of Edisto Beach Code of Ordinances – Councilwoman Hornsby moved to approve the second reading of Ordinance No. 2018-27 to Amend Sections 86-214(a)(16), 86-214(a)(17) of the Town of Edisto Beach Code of Ordinances. These changes are related to banners and flags. Mayor Pro Tem Moore seconded the motion which was approved 4-0.

New Business

- **A.** Award of RFP 2018-16 Edisto Beach Tennis Court Repair Mayor Pro Tem Moore moved to defer the award of RFP 2018-16, Edisto Beach Tennis Court Repair, to give Administration time to pursue alternatives that have recently come to light. Councilwoman Smyer seconded the motion which was approved 4-0.
- **B.** Award of RFP 2018-15 Edisto Beach Pump House Rehab 81 Gun Bluff Mayor Pro Tem Moore moved to award RFP 2018-15 for the Edisto Beach Pump House Rehab, 81 Gun Bluff to HNI/The Interchange for a cost not to exceed \$6,810 to be paid from Sewer R&R. Sewer R&R has a balance of \$209,949. Councilwoman Smyer seconded the motion which was approved 4-0.
- C. Resolution No. 2019-R01 Jury Box Resolution Councilwoman Smyer moved to approve Resolution No. 2019-R01, which reads in part "...the 2019 Jury Box has been prepared pursuant to the requirement of Act #480 of 1980 and is now ready for use." Councilwoman Hornsby seconded the motion which was approved 4-0.
- D. Agreement between Colleton County Sheriff's Office and the Town of Edisto Beach Police Department to Provide the Town of Edisto Beach with Victim's Assistance Councilwoman Hornsby moved to approve the agreement between the Colleton County Sheriff's office and the Town of Edisto Beach Police Department to Provide the Town of Edisto Beach with Victim's Assistance. The motion was seconded by Mayor Pro Tem Moore and approved 4-0.
- **E. TIDE Committee Recommendations** At the December 5, 2018 meeting, the TIDE Committee moved to recommend Town Council proceed with the following: 1) putting up rope and post fencing at McConkey Square to prevent driving into or falling into the ditch and 2) that benches at beach accesses be placed as far back as possible without causing damage to the dune, keeping a view of the ocean (if possible) but placed for longevity, with the final determination of placement being left up to the Public Works Supervisor. There are not enough available funds in local accommodations to fund any new requests. Councilwoman Hornsby moved to handle these recommendations in house as much as possible since the funds are not available. Mayor Pro Tem Moore seconded the motion which was approved 4-0.
- **F.** Beach Renourishment Hurricane Irma According to the beach survey performed after the storm, the Town lost 49,015 cubic yards of sand. CSE has recommended we scrape

sand from the south end of the beach and move it across the beach to the north end stating the storm has accelerated the erosion from the north to the to the south which will shorten the length of time needed between renourishments. If FEMA is funding 75% and the state covers the local match, the Town would be reimbursed for the entire project. The project is estimated to cost \$1,223,779. Mayor Pro Tem Moore moved to go forward with the permitting and application process. Councilwoman Hornsby seconded the motion. Councilwoman Smyer pointed out this motion was not approving the entire project, just the permit and application phase. The project approval would be contingent on funding and further information on where the sand would be taken from/moved to. Mayor Darby called for the vote and the motion was approved 4-0.

G. Recurring Special Event Application, Edisto Chamber of Commerce, 8^{th} Annual Road Race – Councilwoman Smyer moved to approve the Recurring Special Event Application submitted by the Edisto Chamber of Commerce to hold the 8^{th} annual Edisto Road Race on March 16, 2019 beginning at 8:00 a.m. The route of the race is to be determined due to drainage work taking place on Myrtle Street. Mayor Pro Tem Moore seconded the motion, which was approved 4-0.

H. Water and Sewer Recommendations -

- 1. Well Site Tract M Wharton and Smith has recommended pursuing an alternative to the current plan by abandoning the transmission line that connects wells 1, 6 and 2, and installing a new well on Tract M. This would eliminate a portion of the costs to install a new transmission line and the potential of maintenance costs by eliminating older infrastructure. The Water and Sewer Committee recommend this change.
- **2. Project Management Ellison Consulting** The Water and Sewer Committee recommends that Ellison Consulting assume project management responsibilities. Mr. Ellison has submitted a proposal at a cost not to exceed \$45,000 to be funded by Water R&R or contingency funds from the construction fund. The Water R&R balance is \$404.036. Mayor Pro Tem Moore moved to approve both recommendations from the Water and Sewer Committee, seconded by Councilwoman Hornsby. Councilwoman Smyer pointed out that, "the Town had the consultant, Mr. Ellison, look at what was being proposed by Wharton and Smith and after a specific study was done on the feasibility of it, he had determined that is a better plan, and so it's based on this information that we are making this recommendation." Mayor Darby called for the vote and the motion was approved 4 0.
- **I.** Edisto Art Guild Request Mayor Pro Tem Moore moved to defer the Art Guild Request to the February meeting to give the Town time to review the request. Councilwoman Hornsby seconded the motion, which was approved 4-0.
- **J. February Council Worksession Change** Councilwoman Hornsby moved to change the date of the February Worksession from Tuesday, February 12 to Monday, February 11, 2019 due to a conflict with the Beach Advocates meeting. Councilwoman Smyer seconded the motion, which was approved 4-0.
- **K. Personnel Manual Modifications to Annual and Sick Leave Policies** Councilwoman Smyer moved to defer the changes to the personnel manual to give Council more time to look over the proposed changes. Mayor Pro Tem Moore seconded the motion, which was approved 4-0.

Committee Vacancies

A. The Image and Design of Edisto Committee, 2 vacancies – Applications have been received from Peter Beck, Marie Bost and Benny Ferguson. Peter Beck and Marie Bost were elected to serve an additional 3-year term.
