EDISTO RECIPES



Valentine Cookies

2 ounces unsweetened chocolate, chopped ½ cup butter, room temperature

2/3 cup brown sugar

1/3 cup white sugar

1 egg

1 Tbsp red food coloring

1 tsp vanilla extract

2 cups all-purpose flour

½ tsp baking soda

½ tsp salt

1 cup sour cream

1 cup semisweet chocolate chips

Cream cheese frosting (may use canned or your favorite recipe)

Microwave unsweetened chocolate and stir until smooth. In another bowl cream butter and sugars until light and fluffy. Add egg, food coloring, vanilla, and melted chocolate, beating until blended. Mix baking soda and salt to flour and add to other mixture alternately with sour cream, beating after each addition. Stir in the chocolate chips.


Drop by tablespoon approximately 2 inches apart on parchment lined baking sheet. Bake at 375° for 6 to 9 minutes or until set. Cool on wire racks and spread with frosting. Makes approximately 5 dozen cookies. Enjoy!


BEACH NOURISHMENT AND GROIN LENGTHENING PROJECTS

MINUTES December 8, 2016 REGULAR COUNCIL MEETING 6:00 P.M.

Present: Jane S. Darby, Mayor, Susan Hornsby, Mayor Pro Tempore, Jerome Kizer, Crawford Moore, and Patti Smyer, Council Members; *Quorum of Council Present.*

Mayor Darby called the meeting to order and Councilwoman Smyer led those in attendance in an invocation and the Pledge of Allegiance.

Approval of Minutes

Mayor Pro Tem Hornsby moved to approve the minutes of the Regular Council Meeting held November 10, 2016, seconded by Councilman Kizer and approved unanimously. Councilwoman Smyer moved to approve the minutes of the Special Council Meeting held November 18, 2016, seconded by Mayor Pro Tem Hornsby and approved unanimously.

Proclamations and Presentations

- **A.** Presentation to Mayor Jane S. Darby Town Administrator Iris Hill presented a plaque to Mayor Darby in appreciation of her hard work during Hurricane Matthew. Mayor Darby accepted the framed picture and coin from the National Guard on behalf of the entire Town staff.

Old Business

A. Second Reading of Ordinance No. 2016-26, An Ordinance Enacting Section 26-59 Related to Post Disaster Debris Collection – Mayor Pro Tem Hornsby moved to approve the second reading of Ordinance No. 2016-26, An Ordinance Enacting Section 26-59 Related to Post Disaster Debris Collection. The motion was seconded by Councilman Moore and unanimously approved.

New Business

A. Fiscal Year Audit Ending June 30, 2016 – K. Eve McCoy, CPA, reported to Council concerning the audit of the fiscal year 2015-2016. Ms. McCoy directed Council to page one of the report that states Ms. McCoy has audited the financial statements of the governmental activities and related notes. Ms. McCoy pointed out that an audit is not an assurance that there is no error in the financial statement, but based on her best knowledge, the financial statements are "materially correct." The bond ordinance requires that the Town have a certain level of income to

show that the Town is able to meet the debt payments of principal and interest. The Town continued to meet these covenants during the fiscal year. There is a positive bottom line in the general fund. The annual financial report submitted by Ms. McCoy has been posted on the Town website.

The Utilities Department has been busy replacing meters and reading existing meters. Water bills are set to go out before the end of the calendar year. As of today, the Town water system is operating on three wells and the 100,000 gallon elevated storage tank. Well Number 5 was replaced recently and samples were pulled from well number 5 and the ground storage tank. Results of those tests showed no contamination, so well number 5 and booster pump number 1 and the ground storage tank were placed back on line this week. The boil water advisory that was issued on Wednesday, December 7, 2016 has been lifted.

Public Works

Bob Doub, Public Works Director, gave the report for November 2016.

The Public Works Department was busy replacing missing garbage cans and locating and replacing street signs.

Chamber of Commerce

Lisa Harrell, Chamber Director, gave the report for November 2016.

- On Friday, December 9, 2016, the Boat Parade will be held from 5:00 – 7:00 p.m. at Bay Creek Park. Some of the local churches will have choirs singing on the stage during the parade. The tree lighting will take place at the park on Friday night as well.
- The Coffee Shop on Edisto will have the Cotton Blue Band perform on Friday and will hold an "Ugly Sweater Contest".
- On Saturday, December 10 the Edisto Christmas Parade will begin at 2:00 p.m. with Lt. Col. Hyman as the Grand Marshall. There will be a "Poker Walk" with local merchants prior to the parade. Vendors will be at Bay Creek Park from 9:00 – 5:00 p.m.
- After the parade on Saturday, December 10, Santa will be at McConkey's, and Whaley's will host their annual BBQ Fundraiser to benefit Riley Davis. The judging will be at 4:30 p.m. and the BBQ will be \$10 a plate until 7:00 p.m. At 7:00 p.m. there will be an auction.
- On Sunday, December 11, 2016, a benefit concert will be held at Bay Creek Park beginning at 2:00 p.m., with the money raised going to the Ministerial Alliance to help those affected by Hurricane Matthew. A donation of \$10 per person is suggested. Shem Creek Boogie Band and East Coast Party Band will be performing.
