HURRICANES



Hurricanes cause heavy rains that can cause extensive flood damage in coastal and inland areas.

The first and most important thing anyone should do when facing a hurricane threat is to use common sense. **Always be prepared!** Build an emergency kit. Some items to include in your kit are:

- Water, one gallon of water per person per day for at least three days, for drinking and sanitation.
- Food, at least a three day supply of nonperishable food.
- Medications.
- Food and water for your pets.
- Battery powered or hand crank radio and a NOAA Weather Radio with tone alert and extra batteries for both.
- Flashlight and extra batteries.
- First aid kit.
- Whistle to signal for help.
- Dust mask, to help filter contaminated air

and plastic sheeting and duct tape to shelter-in-place.

- Moist towelettes, garbage bags and plastic ties for personal sanitation.
- Wrench or pliers to turn off utilities.
- Can opener for food (if kit contains canned food).
- Local maps.

Make a family emergency plan. Your family may not be together when disaster strikes, so it is important to know how you will contact one another, how you will get back together and what you will do in case of an emergency.

After preparing yourself and your family for possible emergencies, the next step to take is to get involved in preparing your community. We all have a role to play in keeping our hometowns secure from emergencies of all kinds.

EDISTO RECIPES



Blueberry Bread

- 1/3 cup melted butter
- 1 cup sugar
- 3 Tbsps lemon juice
- 2 eggs
- 1 $^{1\!\!/_2}$ cup all purpose flour
- 1 tsp baking powder
- 1 tsp salt
- 1⁄2 cup milk
- 2 Tbsps lemon zest
- 1/2 cups pecans or walnuts
- 1 cup blueberries
- 2 Tbsps lemon juice
- 1/4 cup sugar

Preheat oven to 350° and lightly grease a loaf pan. In bowl mix together first 4 ingredients. Whisk baking powder and salt into flour and add alternately to mixture with milk. Fold in lemon zest, nuts and blueberries and pour mixture in loaf pan. Bake for 60 to 70 minutes or until a toothpick inserted in center of bread comes out clean. Cool bread in pan for 10 minutes. While bread is cooling, combine lemon juice and ¼ cup sugar. Stir until sugar dissolves and drizzle over bread after removing from pan. Enjoy!

BEACH COMBER TREASURES



Loggerhead Turtle (Caretta Caretta) SC State Reptile

Loggerheads received their name from having a relatively large head, which supports powerful jaws that enable them to feed on hard shelled prey such as whelks and conch. The top shell (carapace) is slightly heart shaped and reddish brown in adults while the bottom shell (plastron) is usually a pale yellowish color. The length of the adult is approximately 36 inches and they weigh around 250 pounds.

During the 3 months or so that the female breeds, she will travel hundreds of miles to lay around 35 pounds of eggs and then swim back to her home foraging area, all without eating anything significant. The females lay eggs between late April and early September and may lay three to five nests (sometimes more) during a single nesting season.

When the hatchlings emerge from their nest they move from their nest to the surf where they either swim or are swept through the surf zone to continue swimming away from land for several days. They take up residence in areas where surface waters converge to form local accumulations of floating material such as seaweed.

Loggerheads are the most abundant species of sea turtle found in the US coastal waters. Their major nesting concentrations in the US are found from North Carolina through southwest Florida. They face threats on nesting beaches and in the marine environment. The greatest cause of decline and the continuing threat has been from the incidental capture in fishing gear and trawls, traps, pots, and dredges. NOAA's National Marine Fisheries Service (NMFS) has worked closely with the shrimp trawl fishing industry to develop turtle excluder devices (TEDs) which when large enough exclude even the largest sea turtles. TEDs are required in all shrimp trawl nets.

<u>MINUTES</u> June 8, 2017 REGULAR COUNCIL MEETING <u>6:00 P.M.</u>

Present: Jane S. Darby, Mayor, Susan Hornsby, Mayor Pro Tempore, Jerome Kizer, Crawford Moore, and Patti Smyer, Council Members; *Quorum of Council Present*.

Mayor Darby called the meeting to order. Councilman Moore led those in attendance in the Pledge of Allegiance and an invocation.

Approval of Minutes

A. Regular Council Meeting Minutes, May 11, 2017 – Councilwoman Smyer moved to approve the minutes from the regular Council meeting on May 11, 2017, seconded by Mayor Pro Tem Hornsby and approved unanimously.

B. Special Council Meeting Minutes, May 18, 2017 – Councilman Moore moved to approve the minutes from the special Council meeting on May 18, 2017, seconded by Councilman Kizer and unanimously approved.

C. Special Council Meeting Minutes, June 1, **2017** – Mayor Pro Tem Hornsby moved to approve the minutes from the special Council meeting on June 1, 2017, seconded by Councilwoman Smyer and approved unanimously.

Old Business

A. Second Reading of Ordinance No. 2017-13 to Adopt the FY 2017-18 Budget – Councilman Kizer moved to approve the second reading of Ordinance No. 2017-13 to Adopt the FY2017-18 Budget. Councilman Moore seconded the motion which was unanimously approved.

B. Second Reading of Ordinance No. 2017-14 to Make Certain Amendments to the Town's Purchasing Regulations as Found in Code of Ordinances Section 2-204 – Mayor Pro Tem Hornsby moved to approve the second reading of Ordinance No. 2017-14 to Make Certain Amendments to the Town's Purchasing Regulations as Found in the Code of Ordinances Section 2-204. These changes remove language stating sale of personal property and real estate will go to the lowest, responsive bidder. Councilman Moore seconded the motion, which was unanimously approved.

C. Second Reading of Ordinance No. 2017-15 to Amend Section14-31 of the Town's Code to adopt the Swimming Pool Code – Councilman Moore moved to approve the second reading of Ordinance No. 2017-15 to Amend Section 14-31 of the Town's Code to adopt the Swimming Pool Code. This is not a new code but has been separated from the building code. Mayor Pro Tem Hornsby seconded the motion, which was approved unanimously.

D. Beach Nourishment Project Update -Coastal Science and Engineering - Andrew Giles of Coastal Science and Engineering (CSE) updated Council and those in attendance on the beach nourishment project. Mr. Giles stated that the final groin cap was poured on June 8, 2017 on groin #10. The only thing left to do there on groin #10 is add more armor stone. Hopefully that will be completed on Monday, June 12, 2017, and the cleanup process will be completed by Friday, June 16, 2017. The installation of sand fence has beaun. There was some concern about the placement of sand fencing, which has been addressed. Mr. Giles told Council and those in attendance that CSE has been monitoring cell #31 and taking surveys every week. Graphics were presented to Council, which show some accretion that is volumetrically stable. Mr. Giles stated, "We haven't surveyed all the way out. We haven't brought the boat in and surveyed further out but we believe there's a decent amount of sand that's collected there and it should trend in the accretion state. Even though we do have some spring tides coming up and it is the most critical point right now on the beach, since the beach has been renourished, and is very healthy at this time." Mayor Darby affirmed that CSE will keep monitoring cell #31. Accretion should continue over the summer, according to Mr. Giles.

E. Second Reading of Ordinance No. 2017-16 to Amend Sections: 86-214(c)(1)(a), 86-214(c)(1)(b), 86-214(c)(3), 86-3 and 86-186(1)(c), of the Town of Edisto Beach Code of Ordinances – Councilman Kizer moved to approve the second reading of Ordinance No. 2017-16 to Amend Sections: 86-214(c)(1)(a), 86-214(c)(1)(b), 86-214(c)(3), 86-3 and 86-186(1)(c). Section 86-214(c)(1)(a) deals with

Temporary Contractor signs and changes the language that signs must be removed in 15 days after certificate of occupancy rather than 30 days; Section 86-214(c)(1)(b) deals with yard sale signs and adds yard sale sign language under temporary signs. Section 86-214(c)(3) provides that way finder signs can be used to provide orientation, traffic control or directions to civic organizations in a commercial district, and Town owned parks; Section 86-3 adds the definition for yard sale signs; Section 86-186(1) (c) adds language providing that accessory structures be included under the impervious surface footprint (this does not add impervious area, it just provides that an accessory structure can use part of the impervious surface footprint, if not already used). Mayor Pro Tem Hornsby seconded the motion, which was approved unanimously.

F. Water Improvement Project Update -Town Administrator Hill updated Council and those in attendance on the water improvement project update. Thomas and Hutton has completed the 60% plans. The Town is in the process is issuing the Notice of Intent for the Reverse Osmosis concentrate permit. Thomas and Hutton, Arnold Ellison and staff have scheduled to meet with DHEC to discuss the Discharge Permit as it is critical to the project. The Town is working on easements for the new well. Other critical components are wells, plant, operating and land disturbance. Thomas and Hutton is drafting the write up for public notice and will be working on the concentrate mix model. The Town has completed the re-rating and maintained an A+ rating. The Town has been in discussion with the financial advisor, underwriters and bond counsel about the preliminary official statement (POS) for the 2017 series Combined Water and Sewer System Revenue Bonds. The auditor has provided the procedures which have been reviewed and the Town is waiting on pricing. American Engineering should have a draft to the Town and reviewers on Friday, June 9. The Town is scheduled to comment and finalize the POS by June 14, 2017 and post after that. The underwriters prefer the POS be posted for 4 – 5 days before going to market. Around June 19-21, 2017, the Town should have the rates locked in.

G. Civic Center – On April 13, 2017, Town Council approved new rates for the use of the Civic Center. Included in the charges for exercise classes was a statement that prohibited the use of the auditorium for exercise classes. Additional dialogue between the Town and the civic center exercise class users resulted in a solution whereas the exercise classes will provide additional cleaning as a condition of the auditorium use. Because we were able to remove these services from our cleaning bid, a cost savings was also achieved. Councilwoman Smyer moved to accept the changes to the use of the Civic Center auditorium, seconded by Councilman Moore and approved unanimously.

H. Award of RFP No. 2017-10 Edisto Beach Sand Fence and Beach Plantings – In the June 2017 issue of the Edisto News under the heading of "Favor (continued from page 1)" misinformation was published. The Town of Edisto Beach issued RFP No. 2017-10 Sand Fencing and Beach Plantings on April 18, 2017, that was publicly the South Carolina noticed on Business Opportunities bulletin on April 18, 2017. Bid openings were May 4, 2017 at 2:00 p.m. and five bids were received. The lowest bidder, Coastal Transplant, Inc. (\$87,960.00) was not recommended since their bid contained conditions outside the bid specifications. The next lowest responsive bidder was EarthBalance with a bid of \$105,550.00. Councilman Moore wanted to disclose that an old partner of his was associated with Henley Construction, so he recused himself. He does not now nor never has had an interest in Henley Construction and the recusal was not necessary. Henley Construction (\$162,962) was the highest bidder and was not considered for award of this project.

The Town is concerned that misinformation is being published, even after meeting with the Editor on May 16 and providing the correct information prior to the article being published. The Town Administrator contacted Mr. King on May 30, 2017, when the article was posted on the Edisto News Facebook page and explained there was incorrect information in the article and the article needed to be corrected or removed. The Town also posted a comment on the Edisto News Facebook page with the correct information that was subsequently removed. On June 1, 2017, the Town Administrator once again contacted Mr. King about the article and was told it had been corrected which is in fact untrue.

The Town has also been in contact with the low bidder, Coastal Transplant, Inc. who stated they had been contacted and told the award of the bid was given to a councilperson's firm. They told the person who contacted them they were not surprised they did not receive the bid award because they could not meet the bid specifications.

New Business/Appearances

A. Request for Proposals No. 2017-01 IT Services Award – Councilman Kizer moved to approve the award of RFP No. 2017-01 IT Services to VC3. Proposals were received and staff heard presentations from the top two ranked firms and the committee recommends awarding the bid to VC3, our current provider. VC3 has agreed to continue providing IT services on a one-year probationary basis to see if service issues can be resolved. If service issues can be resolved, they have agreed to renew the contract for an additional five years at the current service price. The motion was seconded by Councilwoman Smyer and approved unanimously.

B. Resolution No. 2017-17 Bay Creek Park and Market Rules - Mayor Pro Tem Hornsby moved to approve Resolution 2017-17 to update the Bay Creek Park and Market Rules. These changes consist of separation of the Bay Creek Park Rules and the Market Rules. The section dealing with restrooms was removed since the park has restroom facilities. Significant proposed changes in the Bay Creek Park rules are: 1) allowance of glass containers, under supervision, 2) addition of statement prohibiting amusement or carnival-type rides, 3) removal of Town Council approval when serving alcohol, and 4) updates to the liability section under the advisement of the Town Attorney. Significant changes in the Market Rules include: 1) addition of a mission statement, 2) addition of a market agreement form, 3) addition of licensing requirements for food vendors, 4) addition of a vendor concern form, and 5) no refunds for "no shows". Vendors who cancel or provide an excuse for absence will continue to receive a refund. Councilman Kizer seconded the motion, which was unanimously approved.

C. Special Event Application – 32nd Annual Hackett July 4th Parade – Councilwoman Smyer moved to approve the special event application for the 32nd Annual Hackett July 4th Parade to be held July 4, 2017 on Myrtle Street between Mikell and Billow Streets and approve closing Myrtle Street between Mikell and Billow Streets from the hours of 9:30 a.m. until 11:30 a.m. Councilman Moore seconded the motion, which was unanimously approved.

D. Edisto Marina Association and the Marina at Edisto Beach Sponsorship Request for the 2017 Edisto Invitational Billfish Tournament – Councilwoman Smyer moved to approve the sponsorship request for the Edisto Marina Association and the Marina at Edisto Beach for the Edisto Invitational Billfish Tournament in the amount of \$10,000 to be paid from alcohol permitting and waiver of the park fees. The event will be held July 19 – 22 from 3:00 p.m. until 11:00 p.m. Councilman Moore seconded the motion, which was approved 4 – 0 with Mayor Darby recused.

E. Resolution No. 2017-R18 to Adjust the Fee for Residential Garbage Container Rollout/Roll-back Service as Authorized by Section 66-78(d) of the Town's Code - Lyons Contracting notified the Town they were not planning to extend the current contract. In discussion with Mr. Lyons, the Town determined the information provided to the contractor had substantially changed resulting in a change in costs to the contractor. The original bid overstated the number of containers to be serviced and indicated that count would increase, when in fact, it has decreased. Lyons Contracting can continue to provide this service for an additional \$2.00 per container per month. The monthly rate would increase from \$4.00 to \$6.00. Councilman Moore moved to approve Resolution No. 2017-R18 to Adjust the Fee for Residential Garbage Container Roll-out/Roll-back Service as Authorized by Section 66-78(d) of the Town's Code, seconded by Councilwoman Smyer and approved unanimously.

F. Emergency Operations Plan and Hurricane

Plan – Councilman Kizer moved to approve the Emergency Operations Plan and Hurricane Plan. These plans are reviewed and updated annually. The notable changes are the re-entry section (removal of levels of re-entry) and a volunteer section. Councilman Moore seconded the motion, which was unanimously approved.

G. Special Event Application – Edisto Marina Association/the Marina at Edisto Beach – 2017 Edisto Invitational Billfish Tournament – Councilman Moore moved to approve the special event application submitted by the Edisto Marina Association and the Marina at Edisto Beach to hold the 2017 Edisto Invitational Billfish Tournament, seconded by Councilwoman Smyer. The Tournament will be held July 19 – 22 at the Marina at Edisto Beach and Bay Creek Park. The motion was approved 4 – 0 with Mayor Darby recused.

H. Mosquito Control Sub-recipient Grant Funding Allocation Agreement – Councilwoman Smyer moved to approve the Mosquito Control Sub-Recipient Grant Funding Allocation Agreement and authorize the Town Administrator to execute said agreement. The Department of Health and Environmental Control has awarded the Town of Edisto beach \$2,216.00 for the purchase of mosquito control insecticides. The funding is valid for the period of July 1, 2017 through April 16, 2018. Mayor Pro Tem Hornsby seconded the motion, which was approved unanimously.

I. Special Event Application – The Marina at Edisto Beach – Captain Jim Bost Memorial Tournament – Councilman Kizer moved to approve the special event application from The Marina at Edisto Beach to hold the Captain Jim Bost Memorial Tournament on June 17, 2017 from 4:00 p.m. – 8:00 p.m. at the Marina at Edisto Beach. The sponsors are aware that there is an event at Bay Creek Park the same day. There will be music on the dock from 4:00 – 8:00 p.m. Councilman Moore seconded the motion, which was approved 4 – 0 with Mayor Darby recused.

Committee Vacancies

A. Accommodations Tax Advisory Board – 2 vacancies – Councilwoman Smyer moved to approve advertising for the vacancies of Stefanie Jumper (at large) and Van Maxwell (Hospitality), which will expire on August 1, 2017. Mayor Pro Tem Hornsby seconded the motion, which was approved unanimously.

Departmental Reports and Committee Updates

Mayor Darby introduced David Smalls, the new Director for the Colleton County Legislative Delegation.

Court Clerk Krystal Parsons has collected \$3,171.00 in late payments.

Coffee with the Chief will be June 21, 2017 from 8:00 - 9:30 at the Coffee Shop on Docksite Road.

Chief George Brothers stated that during the early morning hours of April 16, 2017 there were at least five vehicles that had items removed from them including cell phones, checks, cash, purses and jewelry. The thefts occurred at 1802 Lee Street, 1501B Palmetto Blvd, 705 Dawhoo Street, 1511 Marianne Street, and 1319 Chancellor Street. During one of the incidents, a resident spotted an individual going through a vehicle and yelled at the thief. In response, the suspect pulled a handgun and fired several rounds that struck the residence. No one was injured in these incidents. No charges have been filed regarding the firearm at this time. That investigation is ongoing. Chief Brothers stated that investigators were able to identify a possible suspect vehicle using the License Plate Reader that captures data on vehicles entering the town. Working in conjunction with the Colleton County Sheriff's Office, the Walterboro Police Department and the Charleston County Sheriff's Office, multiple suspects were identified who also participated in the thefts. According to Chief Brothers, excellent work and diligence on the part of the investigators and a cooperative effort with other agencies led to the recovery of stolen items and the arrest of the various suspects. According to Brothers, "This was an intensive investigation. There were very few leads immediately after the incident and investigators had to work hard to identify the suspects and information to make the arrests. I encourage everyone to take the same personal safety precautions here that they do at home. Remove valuables from your vehicle and lock your vehicles at night."

The Public Works Department has been busy cleaning beach accesses, trimming vines and bushes, cleaning bike paths and working with Natalie Kantz to beautify Town Hall and the Town-owned parks.

Westbank Construction has finished the beach access stabilization and BZ Construction is working on rope fencing, bike racks, benches, garbage can enclosures and signage at each beach access. The "Danger Keep Back" signs in front of the groins are being installed. Horseshoe Crab informational signs have been put up from beach access 33 – 36. Mr. Doub met with the Department of Transportation concerning drainage issues and collapsing retaining walls on several properties on Palmetto Boulevard. Scraping along Palmetto Boulevard and chips in curbs and gutters after Hurricane Matthew were also addressed by DOT.
