<u>Jellyfish</u>



Please note that jellyfish are active this time of year. Please see the information below from the Mayo Clinic on jellyfish:

Diagnosis

You generally won't need to see your doctor for a jellyfish sting. If you do visit your doctor, he or she will be able to diagnose your injury by looking at it.

Sometimes treatment is based on the type of jellyfish that caused the sting. Your doctor may collect samples of the stingers.

Treatment

Treatment for jellyfish includes first-aid care and medical treatment, depending on the type of jellyfish, the severity of the sting and your reaction to it.

First-aid care

Most jellyfish stings can be treated as follows:

- Rinse the area with vinegar.
- Carefully pluck visible tentacles with a fine tweezers.

Soak the skin in hot water. Use water that's 110 to 113 F (43 to 45 C). If a thermometer isn't available, test the water on an uninjured person's hand or elbow — it should feel hot, not scalding. Keep the affected skin immersed or in a hot shower for 20 to 45 minutes.

Steps to avoid

These actions are unhelpful or unproved:

- Scraping out stingers
- Rinsing with seawater
- Rinsing with human urine
- Rinsing with fresh water
- Applying meat tenderizer
- Applying alcohol, ethanol or ammonia
- Rubbing with a towel
- Applying pressure bandages

Medical treatment

- Emergency care. Someone having a severe reaction to a jellyfish sting may need cardiopulmonary resuscitation (CPR), life support or, if the sting is from a box jellyfish, antivenin medication.
- Oral medicine. A rash or other skin reaction due to delayed hypersensitivity may be treated with oral antihistamines or corticosteroids. You may also be given oral pain medicine.
- Eye flushing. A jellyfish sting occurring on or near an eye requires immediate medical care for pain control and a good eye flushing. You will likely be seen by a doctor specializing in eye care (ophthalmologist).

Mayor Darby led those in attendance in the Pledge of Allegiance and an invocation.

Mayor Darby gave a State of the Town Address. A printed copy of her speech is attached to these minutes.

Approval of Minutes

A. Regular Council Meeting Minutes, May 10, 2018 – Councilman Kizer moved to approve the minutes from the regular Council meeting from May 10, 2018, seconded by Councilman Moore and approved unanimously.

Old Business

A. Second Reading of Ordinance No. 2018-11 to Adopt the Fiscal Year 2018-2019 Budget – Mayor Pro Tem Moore moved to approve the second reading of Ordinance No. 2018-11 to Adopt the Fiscal Year 2018-2019 Budget including the Chamber budget which was seconded by Councilman Kizer and unanimously approved.

New Business

- A. First Reading of Ordinance No. 2018-15 to Amend Article II of Chapter 18 of the Town's Code Titled Licenses Mayor Pro Tem Moore moved to approve the first reading of Ordinance No. 2018-15 to Amend Article II of Chapter 18 of the Town's Code Titled Licenses. The revisions are recommended by the Municipal Association of South Carolina to standardize business licensing in the state. Councilwoman Hornsby seconded the motion which was unanimously approved.
- **B.** Lyons Contracting Service Contract Councilwoman Hornsby moved to approve the extension of the contract with Lyons Contracting Service through June 30, 2019 at the current rate of \$6.00 per container for roll out/roll back service on garbage containers.

- Councilwoman Smyer seconded the motion, which was approved unanimously.
- C. Wright 4 U Services Contract Councilwoman Smyer moved to approve the extension of the contract with Wright 4 U Services through June 30, 2019 at the current rate of \$238.50 per week for litter pick up between the causeway and the McKinley Washington, Jr. Bridge. These costs are reimbursed by Charleston County. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.
- **D.** Indigent Defense Contract Mayor Pro Tem Moore moved to approve the extension of the contract with Ashley Hudson-Scott for indigent defense at the current rate of \$200 per case. Councilwoman Hornsby seconded the motion, which was approved unanimously.
- **E.** Special Event Application The Cystic Fibrosis Foundation CF Cycle For Life Councilman Kizer moved to approve the special event application from the Cystic Fibrosis Foundation to use Bay Creek Park as the "start" and "stop" point for their CF Cycle for Life, scheduled for September 29, 2018. Mayor Pro Tem Moore seconded the motion, which was unanimously approved.
- F. Recurring Special Event Form and Request for Sponsorship Edisto Marina Association 2018 Edisto Invitational Billfish Tournament Councilwoman Hornsby moved to approve the recurring special event form for the 2018 Edisto Invitational Billfish Tournament to be held July 18 21, 2018 beginning at 3:00 p.m. and ending at 11:00 p.m. at Bay Creek Park and the Edisto Marina. The motion included a sponsorship \$10,000 from the alcohol permitting fund with park fees waived. Councilman Kizer seconded the motion and the motion was approved 4 0 with Mayor Darby recused.
- G. Commercial Sub-Lease Agreement with Subordination Southern Community Services Councilwoman Hornsby moved to approve the sub-lease with Southern Community Services to lease the Jungle room at the Civic Center for \$550.00 per month for a term of one year from July 1, 2018 June 30, 2019. Mayor Pro Tem Moore seconded the motion which was unanimously approved.
- **H. Civic Center Facility Use Agreement** Councilman Kizer moved to approve the Civic Center Facility Use Agreement that includes action taken by Council regarding the use of the Civic Center for religious worship services. Councilwoman Hornsby seconded the motion which was approved unanimously.
- **I.** Emergency Operations and Hurricane Plan Mayor Pro Tem Moore moved to approve the Emergency

Operations and Hurricane Plan, seconded by Councilwoman Smyer and unanimously approved.

- **J. Special Event Application, Town of Edisto Beach, July 3rd Arts & Crafts Market** Councilwoman Smyer moved to approve the special event application submitted by the Town of Edisto Beach to hold an Arts and Crafts Market on Tuesday, July 3, 2018 from 9:00-4:00 p.m. This event will take the place of the Wednesday market scheduled for July 4th. Councilman Kizer seconded the motion, which was approved 4-0 with Councilwoman Hornsby recused.
- K. Recurring Special Event Form, 33rd Annual Hackett Family 4th of July Parade Mayor Pro Tem Moore moved to approve the recurring special event form for the 33rd Annual Hackett Family 4th of July Parade. The parade will be held on Myrtle Street from Mickell to Billow Street with line-up beginning at 9:00 a.m. Councilwoman Smyer seconded the motion which was approved unanimously.
- **L.** Change Order No. 1 Henley's Construction Co. Inc. Councilwoman Smyer moved to approve Change Order No. 1 with Henley's Construction Company, Inc. reducing the sand fence panel installation from 720 panels to 500 panels. This reduces the contract price by \$15,164.80 for a new contract price of \$79,838.00. Councilman Kizer seconded the motion which was unanimously approved.

Town Administrator Iris Hill gave the finance report for the month ending April 2018. Administrator Hill clarified that the water fund received a percentage of the June water bills. The large amount expended from the water fund has to do with bond payments.
