EDISTO RECIPES



CHRISTMAS MORNING FRENCH TOAST

1 ½ cups half & half

8 eggs

2 Tbsp vanilla extract

1 Tbsp dark brown sugar

8 thick slices bread (French or brioche)

¼ cup butter

34 cup brown sugar

½ cup maple syrup

34 cup chopped nuts

2 Tbsp confectioners' sugar

Mix first 4 ingredients together in large rectangular dish and add bread to soak. Cover and refrigerate overnight. On Christmas morning, preheat oven to 350°. Spread ¼ cup butter in bottom of 9x13 inch casserole dish. Spread brown sugar, maple syrup and nuts over the butter. Lay soaked bread on top and bake for 30 to 35 minutes. Sprinkle with confectioners' sugar and enjoy!

MINUTES October 12, 2017 REGULAR COUNCIL MEETING 6:00 P.M.

Present: Jane S. Darby, Mayor, Susan Hornsby, Mayor Pro Tempore, Jerome Kizer, Crawford Moore, and Patti Smyer, Council Members; *Quorum of Council Present*.

Mayor Darby called the meeting to order and Councilwoman Smyer led those present in the Pledge of Allegiance and an invocation.

Approval of Minutes

- A. Special Emergency Council Meeting Minutes, September 7, 2017 Mayor Pro Tem Hornsby moved to approve the minutes of the Special Emergency Council Meeting, seconded by Councilman Moore and unanimously approved.
- B. Regular Council Meeting Minutes,September 14, 2017 Councilwoman Smyer

moved to approve the minutes of the Regular Council Meeting, seconded by Councilman Kizer and unanimously approved.

Proclamations and Presentations

- **A. Starfish Award Mike Casey** Mr. Casey was presented with a Starfish Award for serving as the Edisto Beach liaison to the Colleton County Emergency Management Division during Hurricane Irma so that Councilman Moore could attend his daughter's wedding.
- **B.** Five Year Service Award Deborah Hargis Mayor Darby congratulated Ms. Hargis on her five years of service and presented her with a pin and certificate.
- **C. Safety Policy Resolution No. 2017-R30** Councilman Moore moved to approve the Safety Policy Resolution, seconded by Councilman Kizer and approved unanimously.
- **D. Earthquake Awareness Proclamation No. 2017-P31** Councilman Kizer moved to approve the Earthquake Awareness Proclamation, seconded by Councilwoman Smyer and approved unanimously.

Old Business

- A. Resolution No. 2017-R12 to Adopt the Local Comprehensive Beachfront Management Plan- Mayor Pro Tem Hornsby moved to approve the recently updated Local Beachfront Management Plan, seconded by councilman Kizer and approved unanimously. Both Councilman Kizer and Councilwoman Smyer thanked Town Administrator Hill for her hard work in getting the updates completed in a timely manner.
- B. Second Reading of Ordinance No. 2017-27 to Amend Sections 14-110(a), 14-114(d), 14-114(h) of the Town of Edisto Beach Code of Ordinances, this Ordinance shall take effect December 21, 2017 Councilwoman Smyer moved to approve the Second Reading of Ordinance No. 2017-27, seconded by Councilman Moore and unanimously approved.
- C. Second Reading of Ordinance No. 2017-28 to amend Sections 14-11(a), 14-11(b), 14-11(c), 14-11(d), 14-111(e),14-113, 14-221(b)(1), 14-221(j) of the Town of Edisto Beach Code of Ordinances The changes to Sections 14-111 and 14-113 are required to meet state minimum requirements. The changes to section 14-221(b)(1) reducing substantial

improvement from 50% to 48% and Section 14-221(j) reducing an unattached or attached unfinished enclosed garage or storage from 300 square feet to 299 square feet provide Community Service Rating points used to calculate savings on Flood Insurance rates. Mayor Pro Tem Hornsby moved to approve the second reading of Ordinance 2017-27, seconded by Councilman Kizer and approved unanimously.

D. TIDE Recommendations (July 13, 2017) – Councilman Kizer moved to approve the recommendations from the TIDE Committee, which are as follows: "...to open up immediately every access that has ability for off-street parking, especially #1A, 2, 5, 6, and 20 and re-visit at the end of the season for evaluation......blade and clean up access #29 at this time for the safety of pedestrians with review by the committee in the fall for evaluation of modifications including landscaping. Councilman Moore seconded the motion, which was unanimously approved.

New Business

- A. Council Recognition of Exemplary Service by Town Employees Mayor Darby moved to approve awarding Town Hall employees an extra day off on November 22, 2017 due to the hard work during Hurricane Irma. Councilman Moore seconded the motion, which was unanimously approved.
- **B. First Reading of Ordinance No. 2017-24 Division 2 Protection of Sea Turtles –**Councilman Kizer moved to table the first reading of Ordinance No. 2017-24, Division 2 Protection of Sea Turtles until after the Council Goal-Setting Retreat in February. Councilwoman Smyer seconded the motion, which was approved unanimously.
- C. First Reading of Ordinance No. 2017-26 to **Enact Article III of Chapter 78 of the Code of** Ordinances of the Town of Edisto Beach **Entitled "Golf Carts" –** Over the past year the Police Department has been tasked with enforcing golf cart regulations and dealing with numerous complaints. In addition to the State Code which regulates golf cart usage, this ordinance would further regulate golf cart operations. The changes include 1) everyone must be in a seat and the driver cannot hold a baby, 2) all golf carts must be registered with requires proof of ownership or long-term rental to obtain a permit and 3) requires rental agencies ensure that golf carts can be legally operated from the renter's location and make state law a part of the contract for rental. Mayor Pro Tem Hornsby moved to approve the

first reading of Ordinance No. 2016-26, seconded by Councilman Moore and unanimously approved.

- **D. First Reading of Ordinance No. 2017-29 to Amend the FY 2017-18 Budget** Councilwoman Smyer moved to approve Ordinance No. 2017-29 to Amend the FY 2017-18 Budget increasing emergency funds by \$250,000 from prior year funds to pay for Hurricane Irma damages. Councilman Kizer seconded the motion, which was approved unanimously.
- E. Amendment #2 (Exhibit C) to Agreement for Professional Services, Coastal Science & Engineering, Post Storm and FEMA Coordination Councilwoman Smyer moved to approve amendment #2 to the agreement for professional services with Coastal Science and Engineering for a not to exceed cost of \$18,347 to be funded from local accommodations funds. The motion was seconded by Mayor Pro Tem Hornsby and unanimously approved.
- F. Amendment #3 (Exhibit D) to Agreement for Professional Services, Coastal Science & Engineering Services for Disaster Recovery Efforts Councilman Kizer moved to approve amendment #3 to the agreement for professional services with Coastal Science and Engineering for disaster recovery efforts at a not-to-exceed cost of \$17,432. These costs will be submitted under Category B costs to FEMA and any local share will be funded from local accommodations funds. Councilman Moore seconded the motion, which was approved unanimously.
- **G. Emergency Purchase Order Security Camera Repair –** Councilman Moore moved to approve the emergency purchase order for the security cameras located at Bay Creek park and at Jungle Road which were damaged during Hurricane Irma. The estimated repair is \$4,346.52. An insurance claim has been submitted. Project costs will be funded from emergency funds. Mayor Pro Tem Hornsby seconded the motion, which was unanimously approved.
- H. Emergency Purchase Order Additional Services Lyons Contracting Mayor Pro Tem Hornsby moved to approve the emergency purchase order for additional services from Lyons Contracting. Prior to Hurricane Irma making landfall, Lyons Contracting moved the garbage containers to the curb to be picked up on September 9. Because an evacuation order was issued by the Governor on September 9, Republic Service did not empty the containers. The Town requested Lyons Contracting move the containers

back under homes prior to the storm. The estimated cost is \$4,200. This will be submitted under Category B costs to FEMA and any local share will be funded from emergency funds. Councilman Moore seconded the motion, which was approved unanimously.

- **Emergency Purchase Order Colleton County** - Storm debris is not being covered by FEMA for Hurricane Irma. Edisto Beach does not have the staff nor equipment to remove storm debris. Typically, the Town will partner with DOT or the County and use their contractor, but since there were other major disasters elsewhere, contractors were not available. SCDOT removed a majority of the storm debris using their own forces. The Town is working with Colleton County to send their staff and equipment on weekends to remove debris. The estimated cost is \$5,000. This will be submitted under Category B costs to FEMA and any local share will be funded from emergency funds. Councilman Kizer moved to approve the emergency purchase order with Colleton County, seconded by Mayor Pro Tem Hornsby, who added that she would like to see the Town pursue their own debris collection contract and directed Administrator Hill to put it out for bids. Colleton County is no longer picking up storm debris. Mayor Darby called for the vote and the motion was approved unanimously.
- **J. Emergency Purchase Order Additional Containers Republic Services –** Because the Town does not have a contractor to remove storm debris, the Town ordered additional containers from Republic Services for the disposal of storm debris by residents. The estimated cost is \$10,000. This will be submitted under Category B costs to FEMA and any local share will be funded from emergency funds. Councilwoman Smyer moved to approve the emergency purchase order, seconded by Councilman Kizer and unanimously approved.
- K. Emergency Purchase Order Emergency Berm - West Bank Construction - After Hurricane Irma made landfall, sand was deposited on Palmetto Boulevard. The recently constructed dune was destroyed by the storm surge as it protected structures from damage. Reestablishment of the emergency protective berm is necessary to provide protection from additional impacts and king tides. Section 2-204 of the Town's Code provides when an emergency affects the public welfare, health and safety, provisions requiring a formal sealed bid do not apply. The Town acquired 4 written quotes from qualified firms and selected West Bank Construction to perform this work as the lowest bidder.

agreement with DOT provides the Town will apply for FEMA funds and the local share will be covered by DOT. The estimated cost is \$75,000. Councilman Moore moved to approve the emergency purchase order, seconded by Councilwoman Smyer and approved unanimously.

- **L. Change Order No. 2 Beach Accesses 17, 19 and 32** Terry Hoff submitted change order #2 that reduces the contract amount by \$`185.00 for a final contract amount of \$73,112.25. Councilwoman Smyer moved to approve the change order, seconded by Councilman Kizer and unanimously approved.
- М. SC Department of Health **Environmental Beachfront** Control **Jurisdictional Lines –** Publication of the proposed state beachfront jurisdictional line revisions and opening of the 30-day public comment period began on October 6, 2017. There are changes being proposed to Edisto Beach jurisdictional lines. Public hearings will be held on October 23 (Beaufort region) October 24 (Charleston region) and October 25 (Grand Strand region). The close of the 30-day public comment period is November 6 and the notification of state adoption of revised beachfront jurisdictional lines is December 8. The implementation of the revised beachfront jurisdictional lines is December 27, 2017. Mayor Darby moved to approve the recommendations of the Beachfront Management Committee to draw up a resolution and work with the resolution and other agencies to ask for a the December deadline of implementation of the proposed jurisdictional Mayor Pro Tem Hornsby seconded the lines. motion. Councilwoman Smyer asked if Council should include in the motion a request to extend the public comment period. Mayor Darby indicated the best way to go about it was to ask for a delay in the implementation date. There being no further discussion, Mayor Darby called for the vote and the motion was approved unanimously.

Committee Vacancies

- **A. TIDE Committee 2 vacancies** Councilman Moore moved to approve advertising two vacancies, one held by Charlie Boozer, Jr. and one by Mickey Van Metre. Mayor Pro Tem Hornsby seconded the motion, which was unanimously approved.
- **B.** Beachfront Management Committee 1 vacancy Councilwoman Smyer moved to approve advertising the vacancy on the Beachfront Management Committee that expires December

12, 2017. This position is currently held by Mr. Bill Davies. Councilman Kizer seconded the motion, which was approved unanimously.

C. Water and Sewer Committee – 1 vacancy – Mayor Pro Tem Hornsby moved to approve advertising the vacancy on the Water and Sewer Committee currently held by Mr. Bob Sandifer. Councilman Moore seconded the motion, which was unanimously approved.
